

# Bentham Wholesale Syndicated Loan Fund

## Monthly fact sheet – June 2017

### Portfolio and Market Returns

The Bentham Wholesale Syndicated Loan Fund had a total return (after standard wholesale fees\*) of 0.00 percent in the month of June, outperforming the benchmark Credit Suisse Leveraged Loan Index (hedged into AUD) after fees by 0.02 percent. On a before fees\* basis the fund returned 0.02 percent for the month, outperforming the benchmark by 0.04 percent.

The June monthly distribution paid was 0.45%\*\*.

### Fund Statistics

At month end, the Fund had a yield to maturity of 6.12% and running yield of 5.73%, with the credit yield spread<sup>^</sup> increasing by 11 basis points to 376 basis points during the month. The Fund had an interest rate duration of 0.42 years and credit duration of 3.93 years.

The discount margin (3 year) for the Index increased by 8 basis points during the month to 442 basis points.

### Leveraged Loan Market

The top performing leveraged loan industries in July were Energy, Food And Drug and Utility with returns (sector performance in USD terms) of 2.51%, 1.69% and 1.27% respectively. The worst performing loan industries were Consumer Durables, Consumer Non-Durables and Metals/Minerals with returns of 0.09%, 0.44% and 0.52% respectively.

### Portfolio Exposures

The Fund's asset allocations are 79.9% in Syndicated Loans, 6.4% in High Yield Bonds, 4.5% in Collateralised Loan Obligations and 9.2% in Cash & Derivative Hedges.

The Fund's three largest industry exposures are 12.1% in Electronics, 9.3% in Diversified/Conglomerate Service and 6.3% in Chemicals, Plastics and Rubber. The Fund's top three company exposures are 3.0% in JPMorgan Chase & Co, 1.0% in Intrawest Holdings S.A.R.L. and 1.0% in First Data Corporation. During the month, the Fund increased its exposure to Brand Energy and Infrastructure Services, Intrawest Operations Group and Nord Anglia Education Finance; with decreased exposures to VENTR 2013-13A, American Axle & Manufacturing and Payless.

\*\* The monthly distribution return is calculated as the distribution amount declared for the month-end divided by the ex-distribution unit price at the start of the month. Bentham intends to achieve an average distribution rate of one month Australian Bank Bill Swap (BBSW) rate plus 3.50% - 4.00% p.a. of the monthly unit price for FY2017 with taxable income. If there is a shortfall of taxable income, the distribution could possibly include a capital return. The current distribution rate setting was based on the running yield of the Fund as at 30 June 2016 and assumes the Fund continues to achieve an equivalent yield for FY2017. Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.
