

Bentham Wholesale Global Income Fund NZD

Monthly fact sheet – October 2016

Portfolio and Market Returns

The Bentham Wholesale Global Income Fund NZD had a total return (after fees*) of 1.27 percent in the month of October, outperforming the benchmark (50% Bloomberg AusBond Bank Bill Index (hedged to NZD), 50% Bloomberg AusBond Composite Index (hedged to NZD)) after fees by 1.80 percent. On a before fees* basis the fund returned 1.33 percent for the month, outperforming the benchmark by 1.86 percent. The main contributors to performance were Global Syndicated Loans, Bank Capital Securities and Collateralised Loan Obligations; whilst the lowest performing sectors included Investment Grade Credit and European Convertibles. A key contributor to positive performance in the month was the Fund's short interest rate position (negative interest rate duration), in a month which was strongly negative for interest rate risk.

The October monthly distribution paid was 0.42%**.

Fund Statistics

At month end, the Fund had a yield to maturity of 6.27% and running yield of 5.30%. Excluding cash the yield to maturity of the Fund was 6.95% and running yield of 5.80%. The credit yield spread[^] increased by 3 basis points to 390 basis points during the month. The Fund had an interest rate duration of -1.69 years and a credit duration of 5.42 years.

Portfolio Asset Allocation

During the month, exposures to Global Syndicated Loans, Bank Capital Securities and Residential Mortgage Backed Securities increased, whilst exposures to Cash and Collateralised Loan Obligations decreased. Current asset allocations are 3.8% in Global High Yield, 0.0% in Domestic Hybrids, 0.8% in European Convertibles, 44.1% in Global Syndicated Loans, 16.0% in Bank Capital Securities, 2.0% in Residential Mortgage Backed Securities, 1.2% in Asset backed securities, 20.3% in Collateralised Loan Obligations, -1.4% in Corporate Credit, 13.2% in Cash, Basis Trades and Derivatives.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are; 9.3% in Banking, 8.6% in Insurance and 6.4% in Electronics. The Fund's top three company exposures are; 2.3% in Aviva, 2.1% in HSBC Bank PLC and 1.8% in QBE Insurance Group.

** The monthly distribution return is calculated as the distribution amount declared for the month-end divided by the ex-distribution unit price at the start of the month. Bentham intends to achieve an average distribution rate of 4.50% - 5.50% for FY2017 with taxable income. If there is a shortfall of taxable income, the distribution could possibly include a capital return. The current distribution rate setting was based on the running yield of the Fund as at 30 June 2016 and assumes the Fund continues to achieve an equivalent yield for FY2017. Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.
