

Bentham Wholesale Global Income Fund

Monthly fact sheet - February 2017

Portfolio and Market Returns

The Bentham Wholesale Global Income Fund had a total return (after fees*) of 0.78 percent in the month of February, outperforming the benchmark (50% Bloomberg AusBond Bank Bill Index, 50% Bloomberg AusBond Composite Index) after fees by 0.63 percent. On a before fees* basis the fund returned 0.81 percent for the month, outperforming the benchmark by 0.66 percent. The main contributors to performance were Bank Capital Securities, Global Syndicated Loans and Global High Yield; whilst the lowest contributing sectors included European Convertibles, Domestic Hybrids and Equity Securities.

The February monthly distribution paid was 0.37%**.

Fund Statistics

At month end, the Fund had a yield to maturity of 5.35% and running yield of 4.12%. Excluding cash the yield to maturity of the Fund was 6.03% and running yield of 4.45%. The credit yield spread^ decreased by 19 basis points to 335 basis points during the month. The Fund had an interest rate duration of -2.15 years and credit duration of 4.78 years.

Portfolio Asset Allocation

During the month, exposures to Global High Yield, Asset backed securities and Cash increased, whilst exposures to Collateralised Loan Obligations and Bank Capital Securities decreased. Current asset allocations are 4.9% in Global High Yield, 0.0% in Domestic Hybrids, 0.6% in European Convertibles, 43.7% in Global Syndicated Loans, 15.2% in Bank Capital Securities, 1.8% in Residential Mortgage Backed Securities, 5.8% in Asset backed securities, 14.2% in Collateralised Loan Obligations, -1.3% in Corporate Credit and 15.2% in Cash, Basis Trades and Derivatives.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are; 10.4% in Banking, 7.6% in Insurance and 5.7% in Electronics. The Fund's top three company exposures are; 2.4% in HSBC Bank PLC, 2.2% in Aviva and 1.7% in QBE Insurance Group.

^{**} The monthly distribution return is calculated as the distribution amount declared for the month-end divided by the ex-distribution unit price at the start of the month. Bentham intends to achieve an average distribution rate of 4.00% - 5.00% for FY2017 with taxable income. If there is a shortfall of taxable income, the distribution could possibly include a capital return. The current distribution rate setting was based on the running yield of the Fund as at 30 June 2016 and assumes the Fund continues to achieve an equivalent yield for FY2017. Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified. ^ Credit yield spread is yield to maturity above the duration adjusted risk free bond rate.
