

# Bentham Global Income Fund NZD

---

## Monthly fact sheet – September 2017

### Portfolio and Market Returns

The Bentham Global Income Fund NZD had a total return (after fees\*) of 1.03 percent in the month of September, outperforming the benchmark (50% Bloomberg AusBond Bank Bill Index (hedged to NZD), 50% Bloomberg AusBond Composite Index (hedged to NZD)) after fees by 1.09 percent. On a before fees\* basis the fund returned 1.10 percent for the month, outperforming the benchmark by 1.16 percent. The main contributors to performance were Global Syndicated Loans, Bank Capital Securities and Asset Backed Securities; whilst the lowest performing sectors included Investment Grade Credit, Global High Yield and Domestic Hybrids.

The September monthly distribution paid was 0.38%\*\*.

### Fund Statistics

At month end, the Fund had a yield to maturity of 5.37% and running yield of 4.06%. Excluding cash the yield to maturity of the Fund was 5.63% and running yield of 4.67%. The credit yield spread<sup>^</sup> increased by 28 basis points to 294 basis points during the month. The Fund had an interest rate duration of -2.35 years and a credit duration of 4.89 years.

### Portfolio Asset Allocation

During the month, exposures to Bank Capital Securities, Basis Trades and Global Syndicated Loans increased, whilst exposures to Cash and Global High Yield decreased. Current asset allocations are 5.2% in Global High Yield, 0.0% in Domestic Hybrids, 1.5% in European Convertibles, 39.1% in Global Syndicated Loans, 25.0% in Bank Capital Securities, 4.9% in Residential Mortgage Backed Securities, 2.0% in Asset backed securities, 13.1% in Collateralised Loan Obligations, 2.1% in Corporate Credit, 6.9% in Cash, Basis Trades and Derivatives.

### Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are; 14.9% in Banking, 9.5% in Insurance and 5.9% in Electronics. The Fund's top three company exposures are; 2.4% in JPMorgan Chase & Co, 1.9% in Groupama Sa and 1.8% in Allianz SE.

\*\* The monthly distribution return is calculated as the distribution amount declared for the month-end divided by the ex-distribution unit price at the start of the month. Bentham intends to achieve an average distribution rate of 4.25% - 4.75% for FY2018 with taxable income. If there is a shortfall of taxable income, the distribution could possibly include a capital return. The current distribution rate setting was based on the running yield of the Fund as at 30 June 2017 and assumes the Fund continues to achieve an equivalent yield for FY2018. Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.
