



Bentham High Yield Fund

Monthly fact sheet – November 2017

Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees*) of -0.05 percent in the month of November, outperforming the benchmark Merrill Lynch High Yield Cash Pay Constrained Index (hedged into AUD) after fees by 0.20 percent. On a before fees* basis the fund returned -0.05 percent for the month, outperforming the benchmark by 0.20 percent.

Fund Statistics

At month end, the Fund had a yield to maturity of 5.65% and running yield 6.39%, with the credit yield spread[^] increasing by 5 basis points to 333 basis points during the month. The Fund had an interest rate duration of 3.99 years and credit duration of 4.07 years.

High Yield Market

For the month, 13 of the 24 industries had positive returns. The top performing industries in November were Food And Drug, Utility and Energy with returns (sector performance in USD terms) of 0.84%, 0.55% and 0.40% respectively. The worst performing industries were Telecommunications, Wireless Communications and Consumer Products with returns of -3.79%, -1.36% and -1.25% respectively.

The credit yield spread[^] for the Index increased by 11 basis points during the month to 357 basis points.

Portfolio Exposures

The Fund's asset allocations are 94.2% in High Yield Bonds, 0.0% in Syndicated Loans and 5.1% in Cash & Derivative Hedges.

The Fund's three largest industry exposures are 10.2% in Buildings and Real Estate, 8.4% in Broadcasting and Entertainment and 8.3% in Finance. The Fund's top three company exposures are 1.8% in Valeant Pharmaceuticals, 1.4% in HCA Inc and 1.4% in iStar Inc. During the month, the Fund increased its exposure to Acrisure, Llc, Burger King and Entegris, Inc.; with decreased exposures to T-Mobile Usa Inc and Nexstar Broadcasting Inc.
