

# Bentham Syndicated Loan Fund NZD

---

## Monthly fact sheet – March 2018

### Portfolio and Market Returns

The Bentham Syndicated Loan Fund NZD had a total return (after standard wholesale fees\*) of 0.25 percent in the month of March, underperforming the benchmark Credit Suisse Leveraged Loan Index (hedged into NZD) after fees by 0.08 percent. On a before fees\* basis the fund returned 0.33 percent for the month, remaining neutral against the benchmark by 0.00 percent.

The March monthly distribution paid was 0.42%\*\*.

### Fund Statistics

At month end, the Fund had a yield to maturity of 5.91% and running yield of 5.68%, with the credit yield spread<sup>^</sup> decreasing by 29 basis points to 337 basis points during the month. The Fund had an interest rate duration of 0.25 years and credit duration of 4.34 years.

### Leveraged Loan Market

The top performing leveraged loan industries in March were Transportation, Metals/Minerals and Retail with returns (sector performance in USD terms) of 0.63%, 0.57% and 0.57% respectively. The worst performing loan industries were Consumer Durables, Consumer Non-Durables and Food/Tobacco with returns of -1.66%, 0.03% and 0.22% respectively.

The discount margin (3 year) for the Index remained flat at 396 bps.

### Portfolio Exposures

The Fund's asset allocations are 76.1% in Syndicated Loans, 6.9% in High Yield Bonds, 4.1% in Collateralised Loan Obligations and 12.9% in Cash & Derivative Hedges.

The Fund's three largest industry exposures are 10.5% in Electronics, 8.2% in Chemicals, Plastics and Rubber and 7.3% in Diversified/Conglomerate Service. The Fund's top three company exposures are 1.2% in Numericable, 1.0% in Burger King and 0.9% in First Data. During the month, the Fund increased its exposure to EG Finco, GVC and Altisource Solutions; with decreased exposures to Tempo Acquisition, ON Semiconductor and Parexel.

\*\* The monthly distribution return is calculated as the distribution amount declared for the month-end divided by the ex-distribution unit price at the start of the month. Bentham intends to achieve an average distribution rate of one month New Zealand Bank Bill Swap (NDBB1M) rate plus 3.00% - 3.50% p.a. of the monthly unit price for FY2018 with taxable income. If there is a shortfall of taxable income, the distribution could possibly include a capital return. The current distribution rate setting was based on the running yield of the Fund as at 30 June 2017 and assumes the Fund continues to achieve an equivalent yield for FY2018. Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.

<sup>^</sup> Credit yield spread is yield to maturity above the NZD forward bank bill curve (duration adjusted swap rates).
