### Portfolio and Market Returns

The Bentham Syndicated Loan Fund had a total return (after fees) of 0.15% in the month of June, outperforming the benchmark (Credit Suisse Leveraged Loan Index hedged into AUD) after fees by 0.05%. On a before fees basis the fund returned 0.21% for the month, outperforming the benchmark by 0.12%.

### Fund Statistics

At month end, the Fund had a yield to maturity of 6.02% and running yield of 5.59%, with the credit yield spread increasing by 7 bps to 362 bps during the month. The Fund had an interest rate duration of 0.17 years and credit duration of 4.19 years.

### Leveraged Loan Market

The discount margin (3 year) for the Index increased by 12 bps during the month to 400 bps.

The top performing leveraged loan industries in June were Retail, Utility and Energy with returns (sector performance in USD terms) of 1.61%, 0.47% and 0.45% respectively. The worst performing loan industries were Consumer Durables, Transportation and Gaming/Leisure with returns of -0.92%, -0.28% and -0.11% respectively.

### Portfolio Exposures

The Fund's three largest industry exposures are 10.8% in Electronics, 8.6% in Chemicals, Plastics and Rubber and 7.8% in Diversified/Conglomerate Service. The Fund's top three company exposures are 1.1% in Burger King, 1.0% in Avolon and 1.0% in First Data Corp. During the month, the Fund increased its exposure to GrafTech Finance, Stars Group and Owens; with decreased exposures to Allied Universal, Radiate and Conduent Business Services.

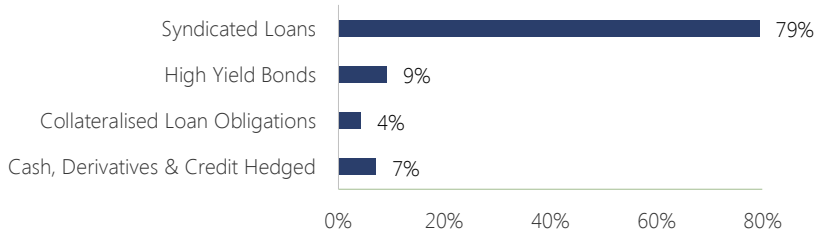

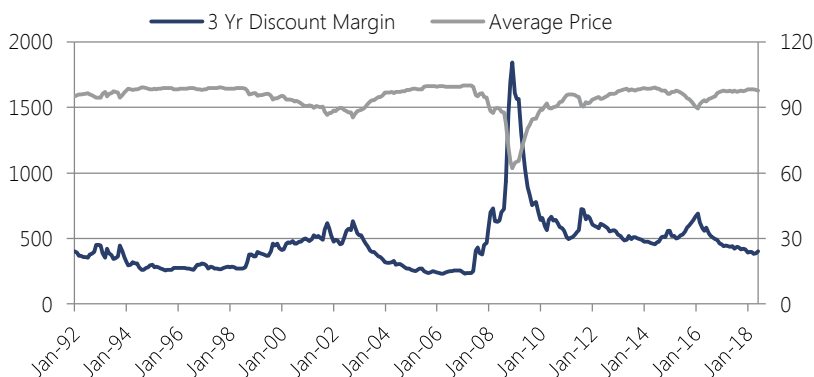
