## Portfolio and Market Returns

The Bentham Syndicated Loan Fund had a total return (after fees) of 0.50% in the month of July, underperforming the benchmark (Credit Suisse Leveraged Loan Index hedged into AUD) after fees by 0.32%. On a before fees basis the fund returned 0.57% for the month, underperforming the benchmark by 0.25%.

## Fund Statistics

At month end, the Fund had a yield to maturity of 6.12% and running yield of 5.60%, with the credit yield spread increasing by 2 bps to 364 bps during the month. The Fund had an interest rate duration of 0.16 years and credit duration of 4.16 years.

## Leveraged Loan Market

The discount margin (3 year) for the Index decreased by 12 bps during the month to 388 bps.

The top performing leveraged loan industries in July were Retail, Transportation and Metals/Minerals with returns (sector performance in USD terms) of 1.22%, 1.18% and 1.05% respectively. The worst performing loan industries were Consumer Durables, Consumer Non-Durables and Aerospace with returns of 0.40%, 0.45% and 0.53% respectively.

## Portfolio Exposures

The Fund's three largest industry exposures are 10.7% in Electronics, 8.7% in Chemicals, Plastics and Rubber and 7.7% in Diversified/Conglomerate Service. The Fund's top three company exposures are 1.1% in Numericable, 1.1% in Burger King and 1.0% in Avolon. During the month, the Fund increased its exposure to Techem, Brookfield and Auris; with decreased exposures to Telesat, Nexstar Broadcasting and Wind.

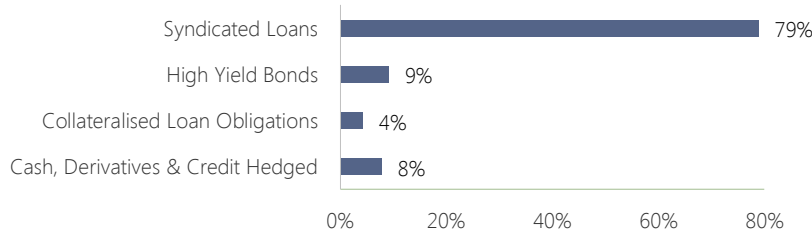

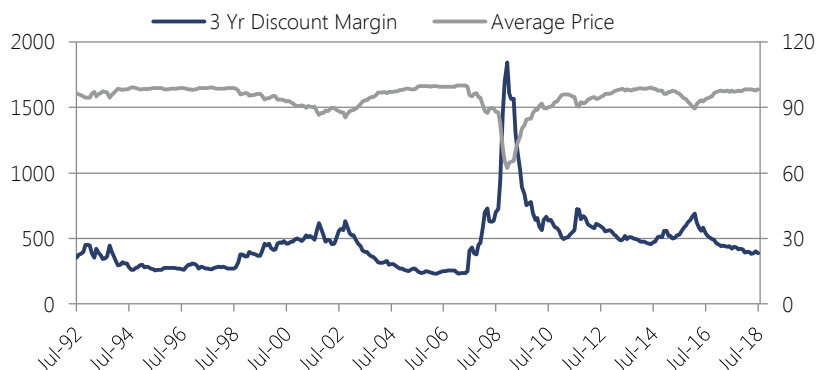
