Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of -0.61% in the month of November, outperforming the benchmark Merrill Lynch High Yield Cash Pay Constrained Index (hedged into AUD) after fees by 0.29%. On a before fees basis the fund returned -0.50% for the month, outperforming the benchmark by 0.39%.

High Yield Market

For the month, 6 of the 23 industries had positive returns. The top performing industries in November were Cable/Wireless Video, Broadcasting and Food And Drug with returns (sector performance in USD terms) of 0.54%, 0.52% and 0.52% respectively. The worst performing industries were Energy, Transportation and Manufacturing with returns of -3.56%, -1.55% and -1.10% respectively.

The credit yield spread for the Index increased by 49 bps during the month to 427 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 9.3% in Buildings and Real Estate, 7.9% in Chemicals, Plastics and Rubber and 6.5% in Oil and Gas. The Fund's top three company exposures are 1.6% in HCA, 1.4% in Priso Acquisition Corporation and 1.1% in iStar. During the month, the Fund increased its exposure to Newmark Group, BMC East and TopBuild Corp; with decreased exposures to Wex, Beacon Roofing Supply and LTI Holdings.

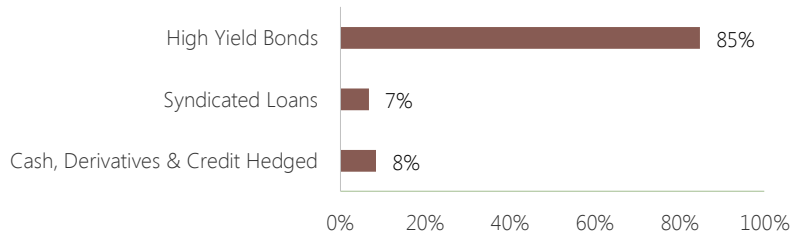

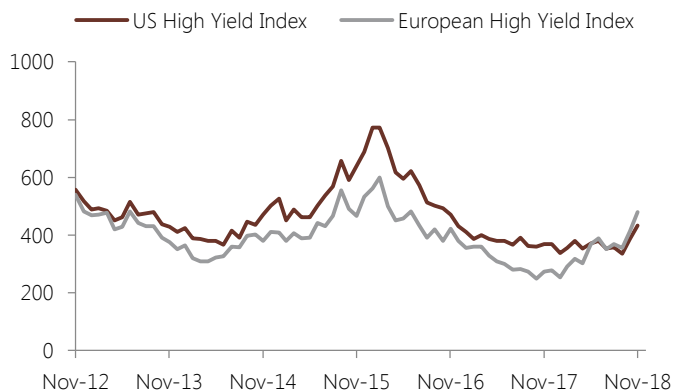
