Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of -1.07% for the month, underperforming the benchmark by 1.22%. The top performing contributors to performance included Global Hybrids, Investment Grade Credit and Residential Mortgage Backed Securities (RMBS); whilst the bottom performing contributors included Global Syndicated Loans, Collateralised Loan Obligations (CLO) and Bank Capital Securities.

Portfolio Asset Allocation

During the month, exposures to Global Syndicated Loans, Cash and Global High Yield increased, whilst exposures to Collateralised Loan Obligations, Basis Trades and Capital Securities decreased. Current asset allocations are 1.8% in Global High Yield, 1.9% in Global Hybrids, 45.6% in Global Syndicated Loans, 13.4% in Capital Securities, 12.1% in Collateralised Loan Obligations, -0.7% in Investment Grade Corporate Credit, 0.9% in Residential Mortgage Backed Securities, 0.4% in Equity and 2.2% in Asset Backed Securities.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 12.1% in CLO, 11.5% in Banking and 5.8% in Electronics. The Fund's top three company exposures are: 2.0% in Allianz SE, 1.7% in Galaxy Clo Ltd - 2013-15x and 1.7% in Abn Amro Bank Nv.






Portfolio Asset Allocation
