Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of 3.43% in the month of January, underperforming the benchmark Merrill Lynch High Yield Cash Pay Constrained Index (hedged into AUD) after fees by 0.94%. On a before fees basis the fund returned 3.46% for the month, underperforming the benchmark by 0.91%.

High Yield Market

For the month, all industries had positive returns. The top performing industries in January were Energy, Food And Drug and Healthcare with returns (sector performance in USD terms) of 5.93%, 5.60% and 5.40% respectively. The worst performing industries were Aerospace, Transportation and Diversified Media with returns of 2.34%, 2.55% and 3.23% respectively.

The credit yield spread for the Index decreased by 97 bps during the month to 433 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 9.7% in Buildings and Real Estate, 9.3% in Chemicals, Plastics and Rubber and 7.1% in Diversified/Conglomerate Manufacturing. The Fund's top three company exposures are 1.7% in HCA, 1.4% in PriSo Acquisition and 1.2% in iStar. During the month, the Fund increased its exposure to Transdigm, Acrisure and Vertiv Group; with decreased exposures to Sprint Spectrum, Transocean and Ball Corp.






