Portfolio and Market Returns

The Bentham Syndicated Loan Fund had a total return (after fees) of -0.13% in the month of March, outperforming the benchmark (Credit Suisse Leveraged Loan Index hedged into AUD) after fees by 0.04%. On a before fees basis the fund returned -0.06% for the month, outperforming the benchmark by 0.11%.

Fund Statistics

At month end, the Fund had a yield to maturity of 5.88% and running yield of 5.62%, with the credit yield spread increasing by 13 bps to 429 bps during the month. The Fund had an interest rate duration of 0.10 years and credit duration of 3.91 years.

Leveraged Loan Market

The discount margin (3 year) for the Index increased by 23 bps during the month to 467 bps.

The top performing leveraged loan industries in March were Energy, Retail and Utility with returns (sector performance in USD terms) of 0.52%, 0.39% and 0.24% respectively. The worst performing loan industries were Consumer Durables, Consumer Non-Durables and Food And Drug with returns of -2.23%, -0.43% and -0.40% respectively.

Portfolio Exposures

The Fund's three largest industry exposures are 9.3% in Electronics, 8.2% in Chemicals, Plastics and Rubber and 7.8% in Diversified/Conglomerate Service. The Fund's top three company exposures are 1.1% in Caesars Resort Collection, 1.0% in Numericable and 0.9% in Sprint Communications. During the month, the Fund increased its exposure to Panther BF Aggregator, Windstream Services and HornBlower; with decreased exposures to CenturyLink, Telenet Finance and Block Communications.
