Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of 1.81% in the month of April, outperforming the benchmark Merrill Lynch High Yield Cash Pay Constrained Index (hedged into AUD) after fees by 0.45%. On a before fees basis the fund returned 1.87% for the month, outperforming the benchmark by 0.52%.

High Yield Market

For the month, all industries had positive returns. The top performing industries in April were Retail, Food And Drug and Transportation with returns (sector performance in USD terms) of 3.61%, 3.20% and 2.61% respectively. The worst performing industries were Aerospace, Forest Prod/Containers and Wireless Communications with returns of 0.28%, 0.75% and 0.89% respectively.

The credit yield spread for the Index decreased by 31 bps during the month to 371 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 9.7% in Chemicals, Plastics and Rubber, 9.4% in Buildings and Real Estate and 7.3% in Electronics. The Fund's top three company exposures are 1.4% in PriSo Acquisition, 1.2% in CSC Holdings and 1.1% in Acrisure. During the month, the Fund increased its exposure to HornBlower, Gateway Casinos & Entertainment and Epicor Software; with decreased exposures to Block Communications, First Quality Finance and Aecom.

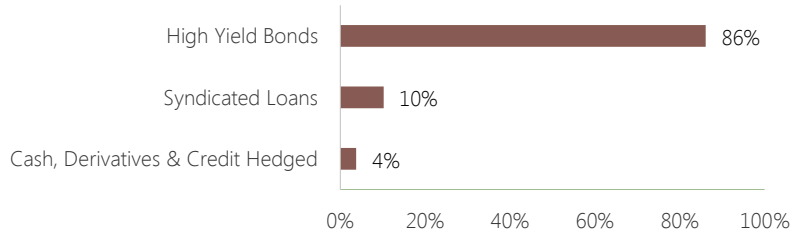

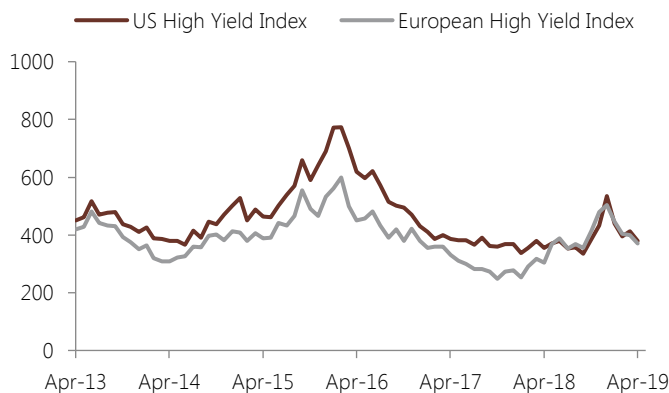
