Portfolio and Market Returns

The Bentham Syndicated Loan Fund had a total return (after fees) of 1.52% in the month of April, underperforming the benchmark (Credit Suisse Leveraged Loan Index hedged into AUD) after fees by 0.02%. On a before fees basis the fund returned 1.59% for the month, outperforming the benchmark by 0.05%.

Fund Statistics

At month end, the Fund had a yield to maturity of 5.64% and running yield of 5.54%, with the credit yield spread decreasing by 21 bps to 408 bps during the month. The Fund had an interest rate duration of 0.10 years and credit duration of 3.88 years.

Leveraged Loan Market

The discount margin (3 year) for the Index decreased by 38 bps during the month to 429 bps.

The top performing leveraged loan industries in April were Retail, Food And Drug and Housing with returns (sector performance in USD terms) of 2.48%, 2.11% and 1.98% respectively. The worst performing loan industries were Energy, Consumer Durables and Metals/Minerals with returns of 0.66%, 0.82% and 0.95% respectively.

Portfolio Exposures

The Fund's three largest industry exposures are 9.8% in Electronics, 8.3% in Chemicals, Plastics and Rubber and 7.9% in Diversified/Conglomerate Service. The Fund's top three company exposures are 1.1% in Caesars Resort Collection, 1.0% in Numericable and 1.0% in Euramax International. During the month, the Fund increased its exposure to Berry Global, The Ultimate Software Group and JBS USA; with decreased exposures to Playa Resorts, Burger King and American Woodmark.






