Portfolio and Market Returns

The Bentham Syndicated Loan Fund NZD had a total return (after fees) of 0.12% in the month of June, underperforming the benchmark (Credit Suisse Leveraged Loan Index hedged into AUD) after fees by 0.04%. On a before fees basis the fund returned 0.18% for the month, outperforming the benchmark by 0.03%.

Fund Statistics

At month end, the Fund had a yield to maturity of 5.84% and running yield of 5.52%, with the credit yield spread increasing by 4 bps to 421 bps during the month. The Fund had an interest rate duration of 0.18 years and credit duration of 3.66 years.

Leveraged Loan Market

The discount margin (3 year) for the Index increased by 9 bps during the month to 460 bps.

The top performing leveraged loan industries in June were Aerospace, Food/Tobacco and Utility with returns (sector performance in USD terms) of 0.68%, 0.56% and 0.49% respectively. The worst performing loan industries were Metals/Minerals, Consumer Durables and Retail with returns of -1.72%, -0.73% and -0.72% respectively.

Portfolio Exposures

The Fund's three largest industry exposures are 9.1% in Electronics, 7.7% in Diversified/Conglomerate Service and 7.5% in Chemicals, Plastics and Rubber. The Fund's top three company exposures are 1.0% in Numericable, 1.0% in Euramax International and 1.0% in Caesars Resort Collection. During the month, the Fund increased its exposure to Allied Universal, Golden Nugget and Capital Automotive; with decreased exposures to Kronos, Genesys Telecommunications Laboratories and Fly Funding.

Bentham intends to achieve the distribution rate for FY2019 with taxable income. If there is a shortfall of taxable income, the distribution may possibly include a capital return.

The current distribution rate setting was based on the running yield of the Fund as at 30 June 2018 and assumes the Fund continues to achieve an equivalent yield for FY2019. Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.

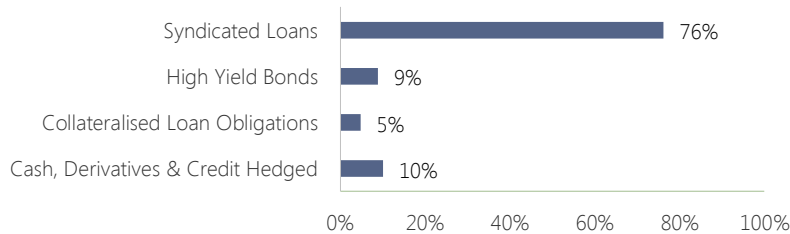
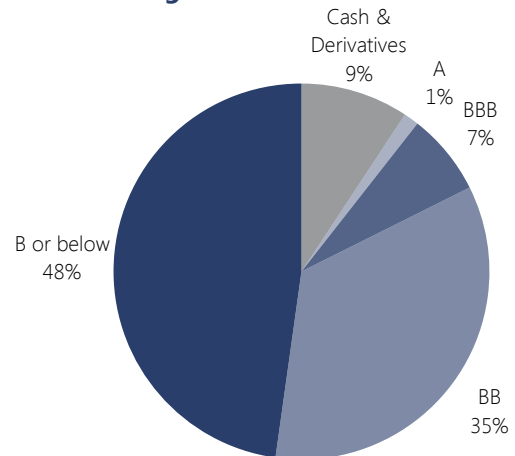
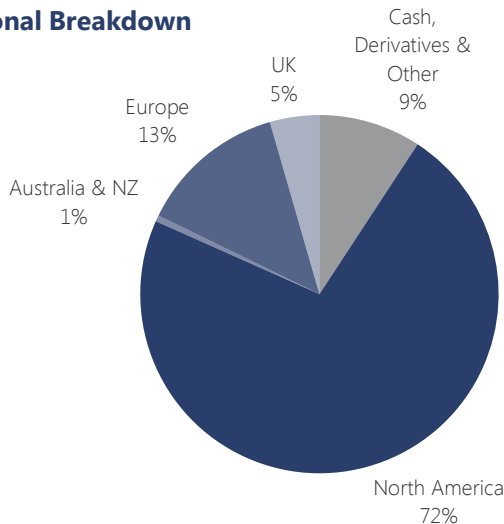

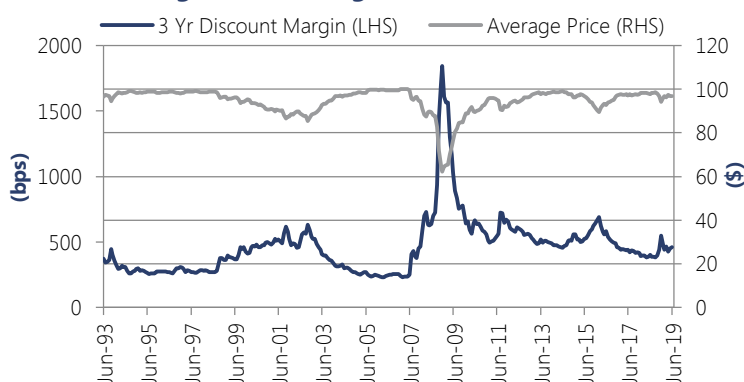
