

### Bentham Global Income Fund NZD

### August 2019

### **Investment Objective**

The Fund provides exposure to global credit markets and aims to generate income with some potential for capital growth over the medium to long term.

#### **Portfolio and Market Returns**

The Bentham Global Income Fund NZD had a total return (after fees) of -0.02% in the month of August, underperforming the benchmark (50% Bloomberg AusBond Bank Bill Index (hedged to NZD), 50% Bloomberg AusBond Composite Index (hedged to NZD)) after fees by 0.88%. On a before fees basis the fund returned 0.05% for the month, underperforming the benchmark by 0.81%.

August was another risk-off month where bonds rallied and credit widened. While the Fed delivered on a promised rate cut, once again, President Trump once again turned up rhetoric. Markets went even further into risk-off mode with Trump pledging an additional 10% increase in tariffs on all remaining Chinese imports. Adding concerns to geopolitical issues were protests in Hong Kong causing the Hang Seng to fall -7.4% during the month.

The top performing contributors to performance included Collateralised Loan Obligations (CLO), Bank Capital Securities and Investment Grade Credit; whilst the bottom performing contributors included Global Syndicated Loans, Equity Securities and European Convertibles.

Going forward, we expect credit market returns to continue to be supported by sound corporate fundamentals, with defaults remaining low. As government bond yields have fallen, credit spreads will provide an increasingly important contribution to achieving a positive real yield. Credit spreads should benefit from further monetary easing globally extending the business cycle.



#### **Portfolio Asset Allocation**


