### Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of 0.66% in the month of August, outperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index<sup>3</sup> (hedged into AUD) after fees by 0.36%. On a before fees basis the fund returned 0.70% for the month, outperforming the benchmark by 0.40%.

### High Yield Market

For the month, 18 of the 23 industries had positive returns. The top performing industries in August were Cable/Wireless Video, Financial and Broadcasting with returns (sector performance in USD terms) of 1.91%, 1.50% and 1.49% respectively. The worst performing industries were Energy, Food And Drug and Telecommunications with returns of -2.45%, -0.73% and -0.42% respectively.

The credit yield spread for the Index increased by 18 bps during the month to 410 bps.

### Portfolio Exposures

The Fund's three largest industry exposures are 9.3% in Buildings and Real Estate, 9.0% in Chemicals, Plastics and Rubber and 7.9% in Electronics. The Fund's top three company exposures are 1.3% in PriSo Acquisition, 1.2% in CSC and 1.1% in Bausch Health. During the month, the Fund increased its exposure to Clear Channel Worldwide, Ascend Performance Materials Operations and Ardagh; with decreased exposures to Mednax, American Woodmark and Horizon Global.

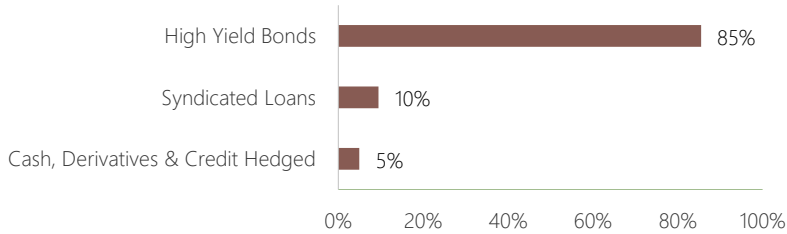

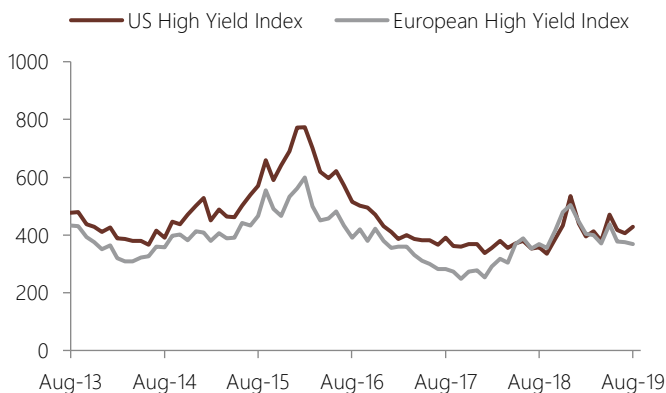
