Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of 0.34% in the month of September, outperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index³ (hedged into AUD) after fees by 0.12%. On a before fees basis the fund returned 0.43% for the month, outperforming the benchmark by 0.21%.

High Yield Market

For the month, 20 of the 23 industries had positive returns. The top performing industries in September were Manufacturing, Retail and Aerospace with returns (sector performance in USD terms) of 1.50%, 1.29% and 0.98% respectively. The worst performing industries were Energy, Wireless Communications and Metals/Minerals with returns of -0.95%, -0.26% and -0.08% respectively.

The credit yield spread for the Index decreased by 11 bps during the month to 399 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 9.9% in Buildings and Real Estate, 8.7% in Chemicals, Plastics and Rubber and 8.0% in Electronics. The Fund's top three company exposures are 1.3% in PriSo Acquisition, 1.2% in CSC and 1.1% in Bausch Health. During the month, the Fund increased its exposure to Sterigenics Nordion Topc, Cheniere Energy Partners and Installed Building Products; with decreased exposures to Itron, AG Merger Sub II and Neon.

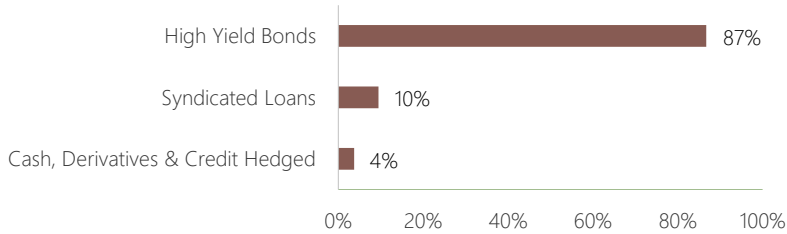

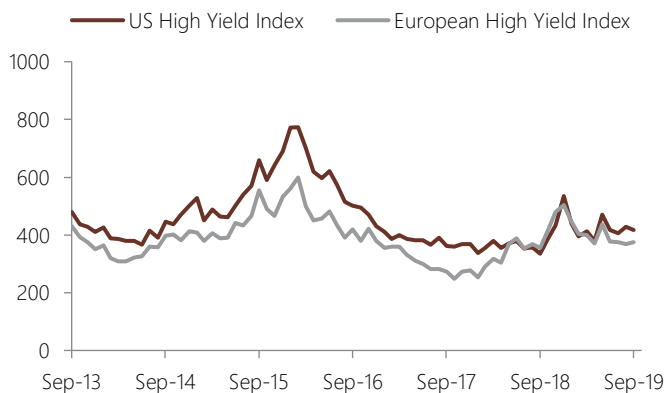
