**Investment Objective**

The Fund provides exposure to global credit markets and aims to generate income with some potential for capital growth over the medium to long term.

**Portfolio and Market Returns**

The Bentham Global Income Fund NZD had a total return (after fees) of -0.03% in the month of October, outperforming the benchmark (50% Bloomberg AusBond Bank Bill Index (hedged to NZD), 50% Bloomberg AusBond Composite Index (hedged to NZD)) after fees by 0.15%. On a before fees basis the fund returned 0.03% for the month, outperforming the benchmark by 0.22%.

October was a mixed month for markets where fundamental economic data was mostly positive in US employment figures and optimism about a US China trade deal boosted global equities. As expected, the Federal Reserve delivered an expected rate cut to 1.75%. US Credit was a mixed story with corporate investment grade rallying and sub investment grade debt generally wider. The RBA cut cash rates at the start of the month to a new low 0.75%. Despite more favourable rates, Australian government bonds and equities both sold-off.

The top performing contributors to performance included Bank Capital Securities, Global Hybrids and Residential Mortgage Backed Securities (RMBS); whilst the bottom performing contributors included Global Syndicated Loans, Collateralised Loan Obligations (CLO) and Equity Securities.

Going forward, we expect credit market returns to continue to be supported by sound corporate fundamentals, with defaults remaining low. As government bond yields have fallen, credit spreads will provide an increasingly important contribution to achieving a positive real yield. Credit spreads should benefit from further monetary easing globally extending the business cycle.

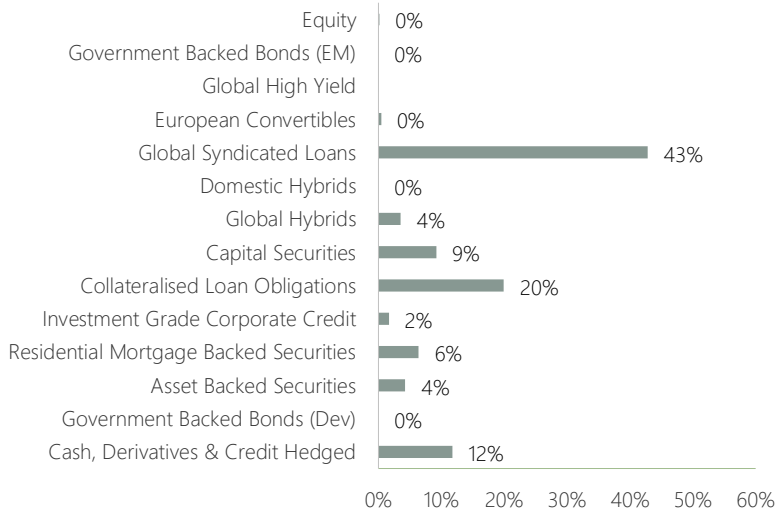
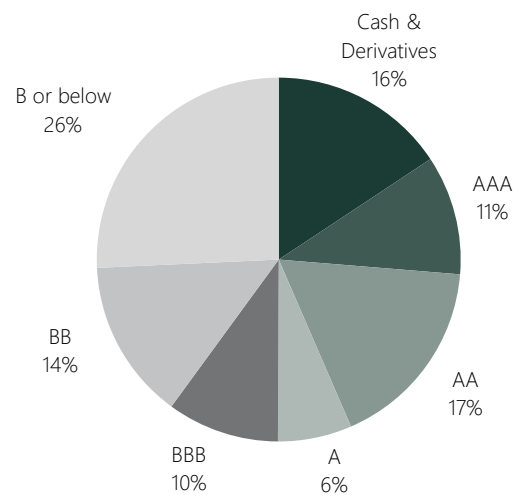
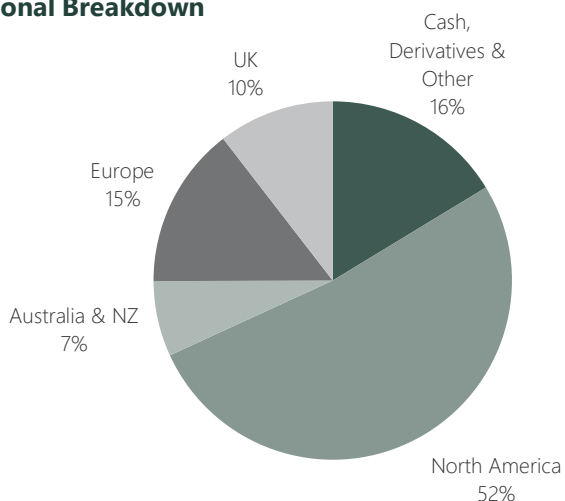
