Investment Objective

To provide exposure to investment grade global asset backed securities (ABS) and generate stable income with some capital growth.

Portfolio Returns

The Bentham Asset Backed Securities Fund had a total return (after fees) of 0.35% in the month of November, outperforming the benchmark (Bloomberg AusBond Bank Bill Index) by 0.27%. On a before fees basis the fund returned 0.38% for the month, outperforming the benchmark by 0.30%.

Portfolio Exposures

The Fund's sector allocations are 34.1% in US Broadly Syndicated Collateralised Loan Obligations (CLO), 19.8% in UK Residential Mortgage Backed Securities (RMBS), 16.0% in European CLO, 8.1% in Cash & Derivatives, 8.0% in Middle Market CLO, 4.3% in Aircraft ABS, 4.1% in Australian RMBS, 2.1% in Credit Card ABS, 1.6% in US Commercial Real Estate (CRE), 1.4% in Auto ABS, 0.3% in European RMBS and 0.2% in Personal Loan ABS.

Contributors

The top performing contributors to performance included US Broadly Syndicated CLO and UK RMBS; whilst the bottom performing contributors included European RMBS and Personal Loan ABS.

Outlook

The Fund remains focused on the higher rated tranches of ABS issuance, offering investors a high credit quality, higher yielding, secured alternatives to investment grade corporate and government bonds, with low interest rate risk.

We place a high value on the structural benefits ("terms") typically included in global ABS structures to help preserve the principal of investors in the higher-rated tranches, such as cashflow priority, security, seniority, and reduction in leverage over time.

The current distribution rate setting was based on the running yield of the Fund as at 30 June 2019 and assumes the Fund continues to achieve an equivalent yield for FY2020.






