Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of 0.67% for the month, outperforming the benchmark by 0.59%. The top performing contributors to performance included Global Syndicated Loans, Bank Capital Securities and Collateralised Loan Obligations (CLO); whilst the bottom performing contributors included Global High Yield, Investment Grade Credit and Residential Mortgage Backed Securities (RMBS).

Portfolio Asset Allocation

During the month, exposures to Global Syndicated Loans, Global High Yield and Residential Mortgage Backed Securities increased, whilst exposures to Cash, Basis Trades and Capital Securities decreased. Current asset allocations are 3.5% in Global High Yield, 3.7% in Global Hybrids, 47.3% in Global Syndicated Loans, 9.5% in Capital Securities, 17.2% in Collateralised Loan Obligations, 0.5% in Investment Grade Corporate Credit, 4.0% in Residential Mortgage Backed Securities, 0.5% in Equity, 2.7% in Asset Backed Securities and 11.2% in Cash, Derivatives & Credit Hedged.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 17.2% in CLO, 8.2% in Banking and 6.2% in Electronics. The Fund's top three company exposures are: 2.2% in Virgin Money Holdings Uk Plc, 1.8% in Galaxy Clo Ltd - 2013-15x and 1.7% in Bilbao Clo - 2x.

Leveraged Loan Market

The top performing leveraged loan industries in November were Food And Drug, Information Technology and Retail with returns (sector performance in USD terms) of 1.19%, 1.17% and 1.16% respectively. The worst performing loan industries were Energy, Metals/Minerals and Consumer Durables with returns of -1.95%, -0.97% and -0.29% respectively.

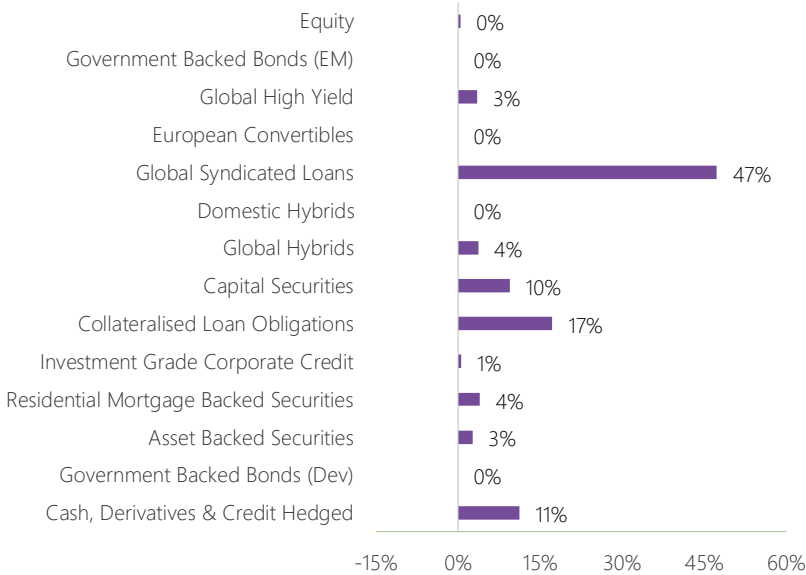
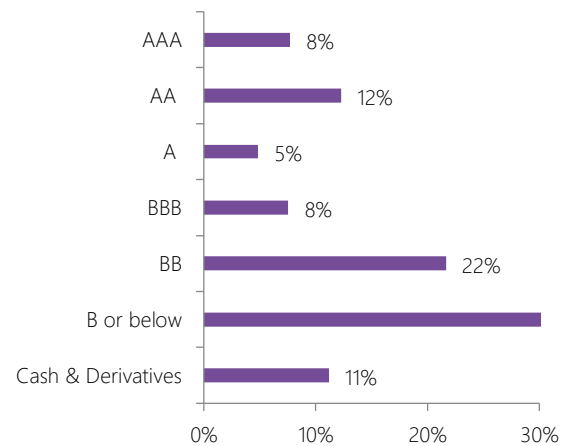
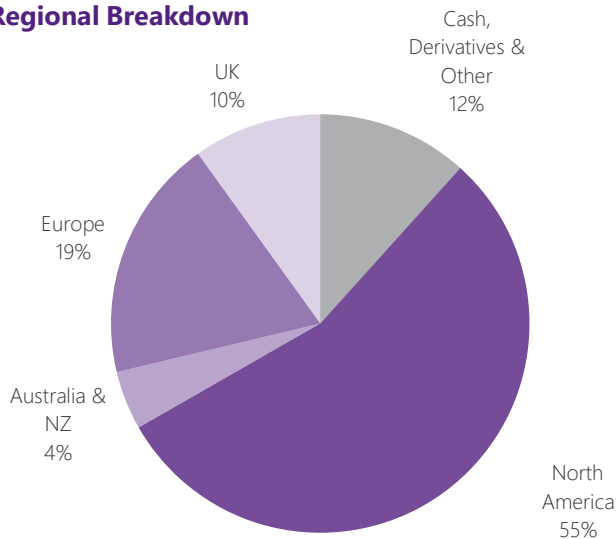
