Portfolio and Market Returns

The Bentham Syndicated Loan Fund had a total return (after fees) of 0.43% in the month of January, underperforming the benchmark (Credit Suisse Leveraged Loan Index hedged into AUD) by 0.05%. On a before fees basis the fund returned 0.51% for the month, outperforming the benchmark by 0.02%.

Fund Statistics

At month end, the Fund had a yield to maturity of 5.20% and running yield of 4.71%, with the credit yield spread increasing by 2 bps to 441 bps during the month. The Fund had an interest rate duration of 0.49 years and credit duration of 3.72 years.

Leveraged Loan Market

The discount margin (3 year) for the Index decreased by 5 bps during the month to 456 bps.

The top performing leveraged loan industries in January were Food And Drug, Utility and Consumer Durables with returns (sector performance in USD terms) of 1.19%, 1.07% and 0.98% respectively. The worst performing loan industries were Metals/Minerals, Aerospace and Gaming/Leisure with returns of -0.15%, 0.23% and 0.30% respectively.

Portfolio Exposures

The Fund's three largest industry exposures are 10.7% in Electronics, 8.9% in Healthcare, Education and Childcare and 7.3% in Chemicals, Plastics and Rubber. The Fund's top three company exposures are 1.1% in Level 3 Communications, 1.1% in Reynolds and 1.1% in Numericable. During the month, the Fund increased its exposure to Zekelman Industries, United Group and Reynolds Consumer Products; with decreased exposures to Ventr 2015-20X, Ineos and KCA Deutag.

The current distribution rate setting was based on the running yield of the Fund as at 30 June 2019 and assumes the Fund continues to achieve an equivalent yield for FY2020. Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.

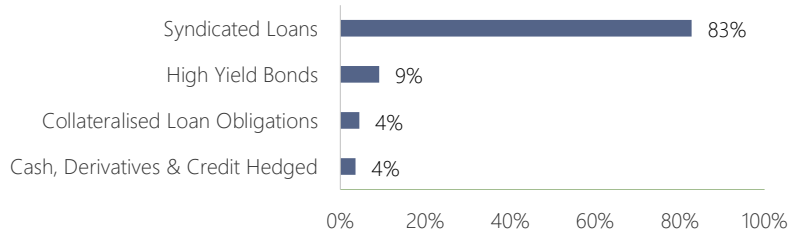

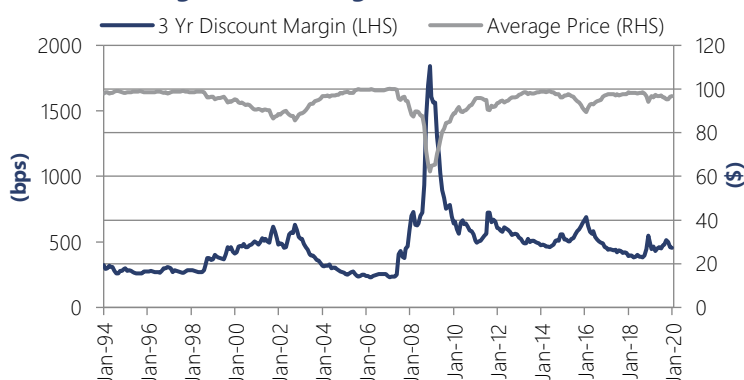
