To provide diversified exposure to securities across global credit markets, with the flexibility to adapt its credit and cash exposure to suit market conditions across the credit cycle, and deliver consistent levels of income.

Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of -9.80% for the month, underperforming the benchmark by 9.89%. The top performing contributors to performance included Global Hybrids, Residential Mortgage Backed Securities (RMBS) and Investment Grade Credit; whilst the bottom performing contributors included Global Syndicated Loans, Collateralised Loan Obligations (CLO) and Bank Capital Securities.

Portfolio Asset Allocation

During the month, exposures to Cash, Global High Yield and Government Backed Bonds (Emerging Market) increased, whilst exposures to Basis Trades, Global Syndicated Loans and Asset Backed Securities decreased. Current asset allocations are 9.8% in Global High Yield, 3.3% in Global Hybrids, 43.9% in Global Syndicated Loans, 9.7% in Capital Securities, 20.3% in Collateralised Loan Obligations, 3.8% in Investment Grade Corporate Credit, 5.3% in Residential Mortgage Backed Securities, 0.0% in Government Backed Bonds (EM), 0.4% in Equity, 2.6% in Asset Backed Securities and 0.9% in Cash, Derivatives & Credit Hedged.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 20.3% in CLO, 7.3% in Banking and 6.6% in Electronics. The Fund's top three company exposures are: 2.1% in Galaxy Clo Ltd - 2013-15x, 2.0% in Virgin Money Holdings Uk Plc and 1.8% in Bilbao Clo - 2x.

Leveraged Loan Market

The top performing leveraged loan industries in March were Food And Drug, Forest Prod/Containers and Financial with returns (sector performance in USD terms) of -3.16%, -9.31% and -9.37% respectively. The worst performing loan industries were Energy, Consumer Non-Durables and Retail with returns of -32.39%, -18.22% and -17.78% respectively.




