Portfolio and Market Returns

The Bentham Syndicated Loan Fund NZD had a total return (after fees) of -13.67% in the month of March, underperforming the benchmark (Credit Suisse Leveraged Loan Index hedged into NZD) by 0.62%. On a before fees basis the fund returned -12.67% for the month, outperforming the benchmark by 0.38%.

Fund Statistics

At month end, the Fund had a yield to maturity of 6.44% and running yield of 4.29%, with the credit yield spread increasing by 104 bps to 604 bps during the month. The Fund had an interest rate duration of 0.79 years and credit duration of 2.62 years.

Leveraged Loan Market

The discount margin (3 year) for the Index increased by 464 bps during the month to 974 bps.

The top performing leveraged loan industries in March were Food And Drug, Forest Prod/Containers and Financial with returns (sector performance in USD terms) of -3.16%, -9.31% and -9.37% respectively. The worst performing loan industries were Energy, Consumer Non-Durables and Retail with returns of -32.39%, -18.22% and -17.78% respectively.

Portfolio Exposures

The Fund's three largest industry exposures are 8.5% in Electronics, 6.0% in Healthcare, Education and Childcare and 5.6% in Chemicals, Plastics and Rubber. The Fund's top three company exposures are 1.0% in Solera, 0.9% in Level 3 Communications and 0.9% in Numericable. During the month, the Fund increased its exposure to Deerfield Dakota, Hestiafloor and Pioneer Energy Services; with decreased exposures to Bausch Health, VICI Properties and Charter Communications.

Bentham intends to achieve the distribution rate for FY2020 with taxable income. If there is a shortfall of taxable income, the distribution may possibly include a capital return.

The current distribution rate setting was based on the running yield of the Fund as at 30 June 2019 and assumes the Fund continues to achieve an equivalent yield for FY2020.





Regional Breakdown




Discount Margin and Average Price of US Loan Market
