To provide exposure to investment grade global asset backed securities (ABS) and generate stable income with some capital growth.

## Portfolio Returns

The Bentham Asset Backed Securities Fund had a total return (after fees) of 1.44% in the month of April, outperforming the benchmark (Bloomberg AusBond Bank Bill Index) by 1.39%. On a before fees basis the fund returned 1.59% for the month, outperforming the benchmark by 1.55%.

## Portfolio Exposures

The Fund's sector allocations are 35.8% in US Broadly Syndicated Collateralised Loan Obligations (CLO), 20.0% in UK Residential Mortgage Backed Securities (RMBS), 19.5% in European CLO, 9.9% in Middle Market CLO, 4.3% in Cash & Derivatives, 3.5% in Aircraft ABS, 2.6% in US Commercial Real Estate (CRE), 1.5% in Australian RMBS, 1.2% in Auto ABS, 1.1% in Credit Card ABS, 0.3% in European RMBS and 0.2% in Personal Loan ABS.

## Contributors

The top performing contributors to performance included European CLO and Aircraft ABS; whilst the bottom performing contributors included Middle Market CLO and European RMBS.

## Outlook

The Fund remains focused on the higher rated tranches of ABS issuance, offering investors a high credit quality, higher yielding, secured alternatives to investment grade corporate and government bonds, with low interest rate risk.

We place a high value on the structural benefits ("terms") typically included in global ABS structures to help preserve the principal of investors in the higher-rated tranches, such as cashflow priority, security, seniority, and reduction in leverage over time.

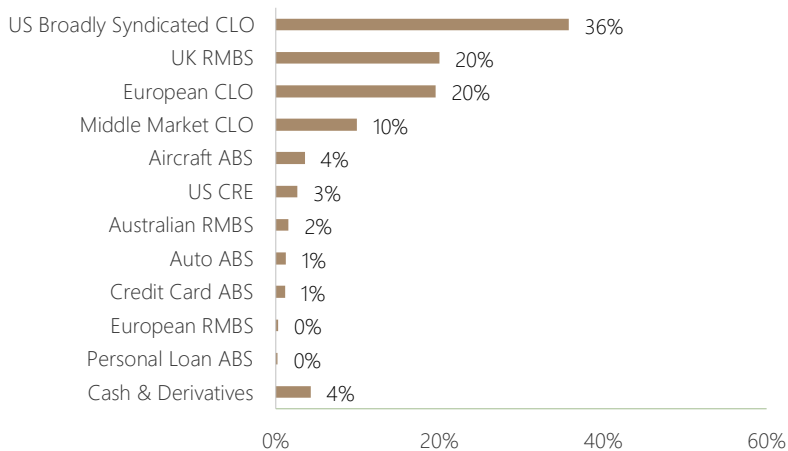
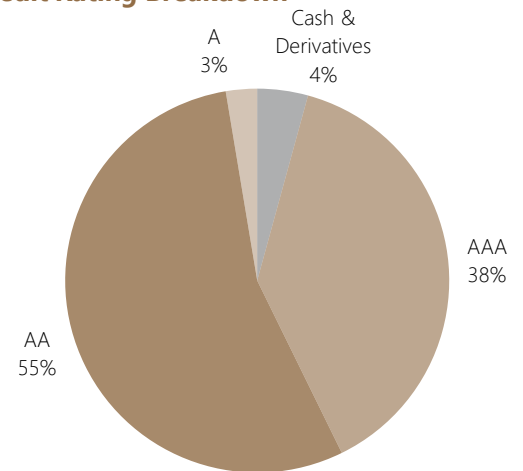
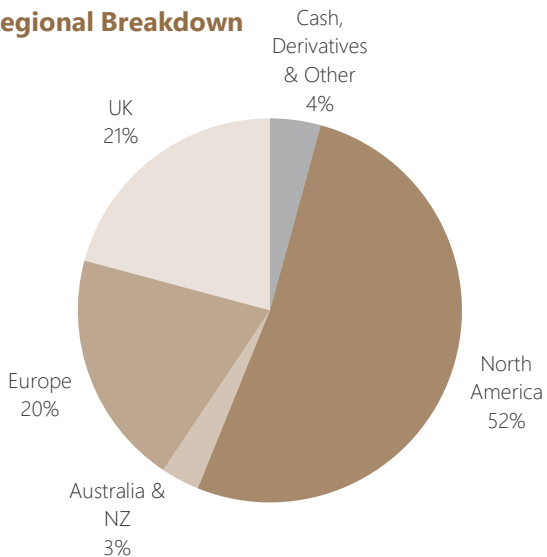
