### Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of 3.38% in the month of April, underperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index<sup>3</sup> (hedged into AUD) by 0.15%. On a before fees basis the fund returned 3.57% for the month, outperforming the benchmark by 0.03%.

### High Yield Market

For the month, 20 of the 23 industries had positive returns. The top performing industries in April were Energy, Gaming/Leisure and Utility with returns (sector performance in USD terms) of 18.28%, 5.16% and 4.70% respectively. The worst performing industries were Aerospace, Broadcasting and Retail with returns of -6.68%, -2.24% and -1.02% respectively.

The credit yield spread for the Index decreased by 113 bps during the month to 760 bps.

### Portfolio Exposures

The Fund's three largest industry exposures are 10.8% in Buildings and Real Estate, 7.9% in Broadcasting and Entertainment and 7.7% in Chemicals, Plastics and Rubber. The Fund's top three company exposures are 1.3% in Bausch Health, 1.1% in PriSo and 1.1% in Solera. During the month, the Fund increased its exposure to Kapla, Jeld-Wen and Broadcom; with decreased exposures to Bausch Health, Marriott and Ingevity.

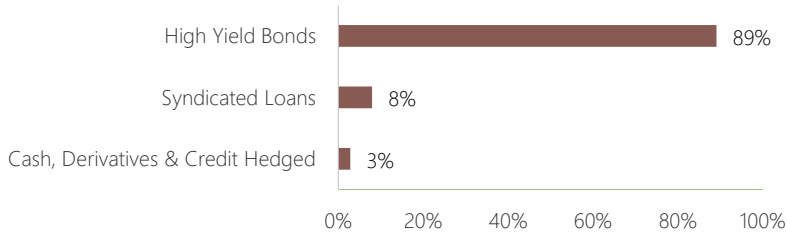

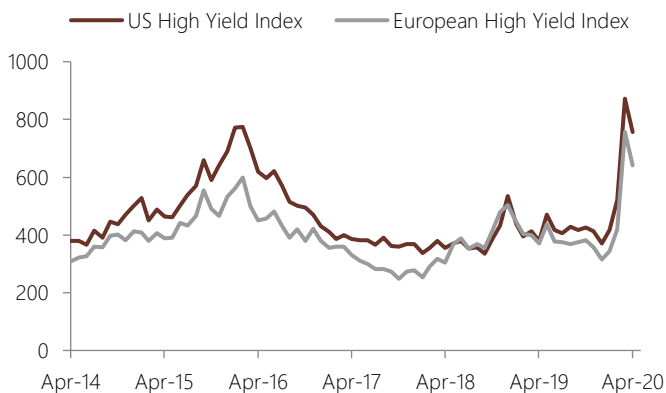
