Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of 3.55% for the month, outperforming the benchmark by 3.54%. The top performing contributors to performance included Global Syndicated Loans, Collateralised Loan Obligations (CLO) and Bank Capital Securities; whilst the bottom performing contributors included Sovereign, Global Hybrids and Global High Yield.

Portfolio Asset Allocation

During the month, exposures to Basis Trades and Capital Securities increased, whilst exposures to Cash, Investment Grade Corporate Credit and Global High Yield decreased. Current asset allocations are 14.0% in Global High Yield, 2.9% in Global Hybrids, 43.3% in Global Syndicated Loans, 10.9% in Capital Securities, 19.3% in Collateralised Loan Obligations, 4.0% in Investment Grade Corporate Credit, 4.8% in Residential Mortgage Backed Securities, 0.3% in Equity, 2.3% in Asset Backed Securities and -2.0% in Cash, Derivatives & Credit Hedged.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 19.3% in CLO, 8.7% in Banking and 7.9% in Electronics. The Fund's top three company exposures are: 2.1% in Bank Of Ireland Group, 1.9% in Virgin Money Holdings Uk Plc and 1.9% in Galaxy Clo Ltd - 2013-15x.

Leveraged Loan Market

The top performing leveraged loan industries in May were Energy, Metals/Minerals and Transportation with returns (sector performance in USD terms) of 11.93%, 7.66% and 5.34% respectively. The worst performing loan industries were Consumer Durables, Utility and Aerospace with returns of 0.12%, 2.30% and 2.30% respectively.


