

# Bentham Global Opportunities Fund

#### **Fund Aim**

To provide diversified exposure to securities across global credit markets, with the flexibility to adapt its credit and cash exposure to suit market conditions across the credit cycle, and deliver consistent levels of income.

#### **Portfolio and Market Returns**

The Bentham Global Opportunities Fund had a before fees return of 1.37% for the month, outperforming the benchmark by 1.37%. The top performing contributors to performance included Global Syndicated Loans, Bank Capital Securities and Collateralised Loan Obligations (CLO); whilst the bottom performing contributors included Investment Grade Credit, Global Hybrids and Asset Backed Securities (ABS).

### **Portfolio Asset Allocation**

During the month, exposures to Global Syndicated Loans, Investment Grade Corporate Credit and Capital Securities increased, whilst exposures to Cash, Collateralised Loan Obligations and Basis Trades decreased. Current asset allocations are 12.7% in Global High Yield, 4.1% in Global Hybrids, 47.9% in Global Syndicated Loans, 12.4% in Capital Securities, 17.2% in Collateralised Loan Obligations, 5.6% in Investment Grade Corporate Credit, 4.4% in Residential Mortgage Backed Securities, 0.3% in Equity, 2.2% in Asset Backed Securities and -6.7% in Cash, Derivatives & Credit Hedged.

### **Portfolio Industry and Issuer Exposures**

The Fund's largest industry exposures are: 17.2% in CLO, 10.3% in Banking and 8.5% in Electronics. The Fund's top three company exposures are: 1.8% in Virgin Money Holdings Uk Plc, 1.7% in Galaxy Clo Ltd - 2013-15x and 1.6% in Bank Of Ireland Group.

### **Leveraged Loan Market**

The top performing leveraged loan industries in June were Energy, Retail and Manufacturing with returns (sector performance in USD terms) of 4.30%, 3.71% and 3.11% respectively. The worst performing loan industries were Forest Prod/Containers, Gaming/Leisure and Consumer Durables with returns of 0.27%, 0.44% and 0.50% respectively.




