Portfolio and Market Returns

The Bentham Syndicated Loan Fund NZD had a total return (after fees) of 2.01% in the month of June, outperforming the benchmark (Credit Suisse Leveraged Loan Index hedged into NZD) by 0.71%. On a before fees basis the fund returned 1.73% for the month, outperforming the benchmark by 0.43%.

Fund Statistics

At month end, the Fund had a yield to maturity of 6.45% and running yield of 5.01%, with the credit yield spread decreasing by 46 bps to 590 bps during the month. The Fund had an interest rate duration of 1.39 years and credit duration of 3.84 years.

Leveraged Loan Market

The discount margin (3 year) for the Index decreased by 34 bps during the month to 700 bps.

The top performing leveraged loan industries in June were Energy, Retail and Manufacturing with returns (sector performance in USD terms) of 4.30%, 3.71% and 3.11% respectively. The worst performing loan industries were Forest Prod/Containers, Gaming/Leisure and Consumer Durables with returns of 0.27%, 0.44% and 0.50% respectively.

Portfolio Exposures

The Fund's three largest industry exposures are 10.0% in Electronics, 8.3% in Healthcare, Education and Childcare and 6.9% in Buildings and Real Estate. The Fund's top three company exposures are 1.0% in Solera, 0.9% in Numericable and 0.9% in Euramax. During the month, the Fund increased its exposure to Jaguar, Serta Simmons and Yum!; with decreased exposures to LD, Pioneer Energy and American Airlines.


