#### **Fund Aim**

To provide investors with a diversified exposure to the US high yield bond market with active allocation between individual securities and industries.

#### **Portfolio and Market Returns**

The Bentham High Yield Fund had a total return (after fees) of 3.62% in the month of July, underperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index<sup>3</sup> (hedged into AUD) by 0.92%. On a before fees basis the fund returned 3.68% for the month, underperforming the benchmark by 0.86%.

## **High Yield Market**

For the month, all industries had positive returns. The top performing industries in July were Broadcasting, Retail and Aerospace with returns (sector performance in USD terms) of 5.41%, 5.34% and 5.10% respectively. The worst performing industries were Food And Drug, Diversified Media and Wireless Communications with returns of 1.57%, 2.90% and 3.33% respectively.

The credit yield spread for the Index decreased by 126 bps during the month to 516 bps.

### **Portfolio Exposures**

The Fund's three largest industry exposures are 10.7% in Buildings and Real Estate, 7.9% in Electronics and 7.6% in Leisure, Amusement, Motion Pictures, Entertainment. The Fund's top three company exposures are 1.4% in NFP, 1.3% in Altice Financing and 1.2% in Epicor Software. During the month, the Fund increased its exposure to National Financial Partners, Epicor Software and MasTec; with decreased exposures to Alpha, Delta Air Lines and Nufarm.






#### **Portfolio Asset Allocation**




### **High Yield Spread to Worst (bps)**
