The Fund provides exposure to global credit markets and aims to generate income with some potential for capital growth over the medium to long term.

Portfolio and Market Returns

The Bentham Global Income Fund had a total return (after fees) of 1.30% in the month of August, outperforming the benchmark (50% Bloomberg AusBond Bank Bill Index, 50% Bloomberg AusBond Composite Index) by 1.50%. On a before fees basis the fund returned 1.26% for the month, outperforming the benchmark by 1.46%.

August continued the positive trend in markets with optimism from monetary policymakers and scientific advances spurring a risk-on appetite for credit markets. At the Virtual Jackson Hole Symposium, the Federal Reserve (Fed) indicated a willingness to offer further support while also adjusting its framework for inflation. The new measure allows "average inflation targeting" to allow for temporary increases beyond the 2% target.

The top contributors to performance included Global Syndicated Loans, Bank Capital Securities and Collateralised Loan Obligations (CLO); whilst the bottom performing contributors included Equity Securities, Investment Grade Credit and Residential Mortgage Backed Securities (RMBS).

There is a surprisingly high level of confidence given the economic backdrop. Countries around the world are now implementing their own strategies to get back to normal, while dealing with second wave of Covid infections. While research has seen positive developments in vaccine testing, anti-viral and more effective indirect therapies, it is the extraordinary Fiscal and Monetary policy which was rapidly deployed that is bridging the activity deficit. We are now 53 days from the US election which has the potential to surprise markets again and potentially remains a risk should neither candidate win with a clear mandate.

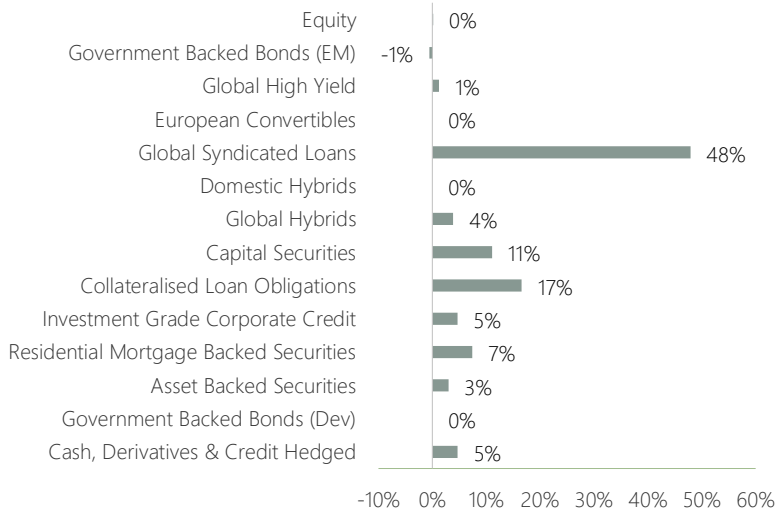
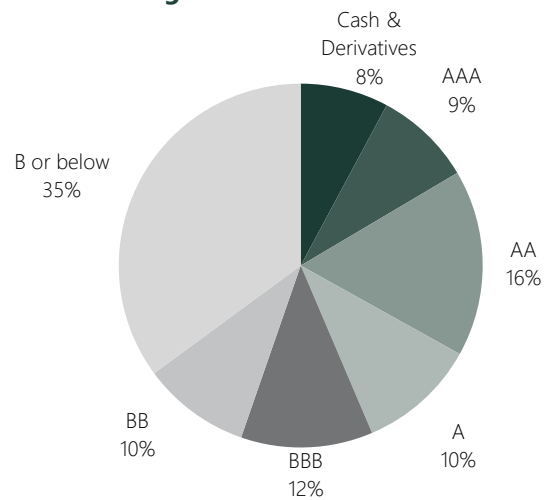
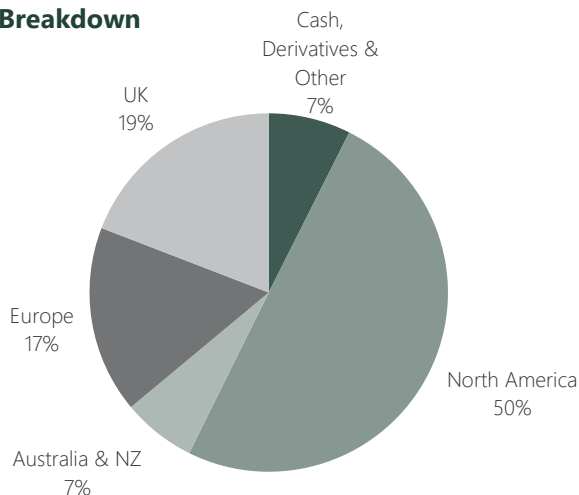
