Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of 1.55% in the month of August, outperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index³ (hedged into AUD) by 0.59%. On a before fees basis the fund returned 1.55% for the month, outperforming the benchmark by 0.59%.

High Yield Market

For the month, all industries had positive returns. The top performing industries in August were Gaming/Leisure, Energy and Diversified Media with returns (sector performance in USD terms) of 3.06%, 2.26% and 2.07% respectively. The worst performing industries were Cable/Wireless Video, Utility and Consumer Products with returns of 0.11%, 0.33% and 0.35% respectively.

The credit yield spread for the Index decreased by 16 bps during the month to 500 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 10.3% in Buildings and Real Estate, 7.9% in Electronics and 7.8% in Leisure, Amusement, Motion Pictures, Entertainment. The Fund's top three company exposures are 1.2% in Altice, 1.1% in Standard Industries and 1.1% in Vertical. During the month, the Fund increased its exposure to Standard Industries, Sensata Technologies and Xerox; with decreased exposures to Delta Air Lines, Nouryon and Aramark Services.






Portfolio Asset Allocation




Regional Breakdown
