Portfolio and Market Returns

The Bentham Syndicated Loan Fund had a total return (after fees) of 2.10% in the month of August, outperforming the benchmark (Credit Suisse Leveraged Loan Index hedged into AUD) by 0.64%. On a before fees basis the fund returned 2.06% for the month, outperforming the benchmark by 0.61%.

Fund Statistics

At month end, the Fund had a yield to maturity of 5.36% and running yield of 4.27%, with the credit yield spread decreasing by 44 bps to 505 bps during the month. The Fund had an interest rate duration of 1.49 years and credit duration of 3.87 years.

Leveraged Loan Market

The discount margin (3 year) for the Index decreased by 40 bps during the month to 589 bps.

The top performing leveraged loan industries in August were Aerospace, Consumer Non-Durables and Energy with returns (sector performance in USD terms) of 3.72%, 2.85% and 2.61% respectively. The worst performing loan industries were Utility, Financial and Food And Drug with returns of 0.01%, 0.63% and 0.76% respectively.

Portfolio Exposures

The Fund's three largest industry exposures are 9.6% in Electronics, 8.3% in Healthcare, Education and Childcare and 7.0% in Chemicals, Plastics and Rubber. The Fund's top three company exposures are 0.9% in Numericable, 0.8% in Solenis and 0.8% in Euramax. During the month, the Fund increased its exposure to Alchemy Copyrights, Hudson River Trading and Asplundh Tree Expert; with decreased exposures to Golden Nugget, CommScope and Cedar Fair.
