Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of 0.22% for the month, outperforming the benchmark by 0.21%. The top performing contributors to performance included Global Syndicated Loans, Investment Grade Credit and Collateralised Loan Obligations (CLO); whilst the bottom performing contributors included Bank Capital Securities, Global Hybrids and Global High Yield.

Portfolio Asset Allocation

During the month, exposures to Capital Securities, Global High Yield and Basis Trades increased, whilst exposures to Investment Grade Corporate Credit, Cash and Collateralised Loan Obligations decreased. Current asset allocations are 14.8% in Global High Yield, 4.8% in Global Hybrids, 52.9% in Global Syndicated Loans, 15.2% in Capital Securities, 8.1% in Collateralised Loan Obligations, 0.0% in Investment Grade Corporate Credit, 3.4% in Residential Mortgage Backed Securities, 0.2% in Equity, 2.0% in Asset Backed Securities and -1.4% in Cash, Derivatives & Credit Hedged.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 14.6% in Banking, 8.1% in CLO and 7.5% in Electronics. The Fund's top three company exposures are: 2.2% in Commerzbank AG, 1.9% in Qantas Airways Ltd and 1.9% in Virgin Money Holdings Uk Plc.

Leveraged Loan Market

The top performing leveraged loan industries in September were Retail, Consumer Durables and Consumer Non-Durables with returns (sector performance in USD terms) of 2.28%, 1.98% and 1.88% respectively. The worst performing loan industries were Media/Telecommunications, Utility and Healthcare with returns of 0.03%, 0.23% and 0.32% respectively.

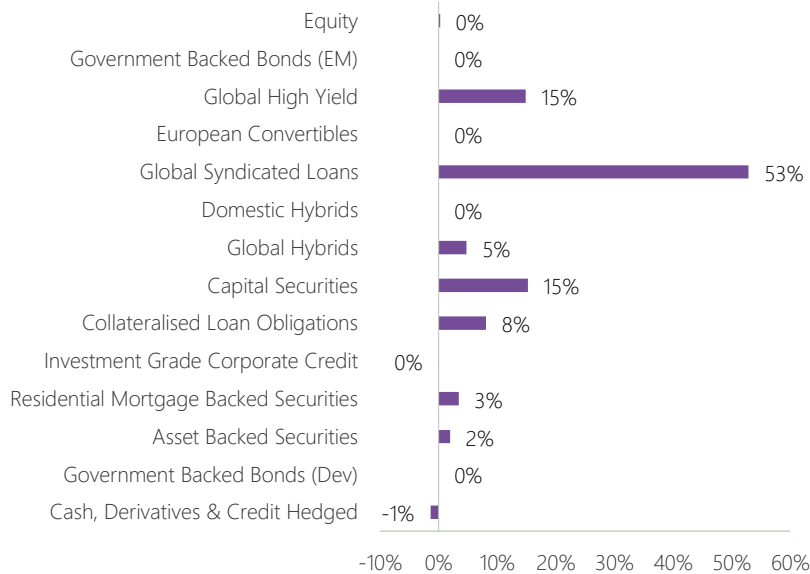
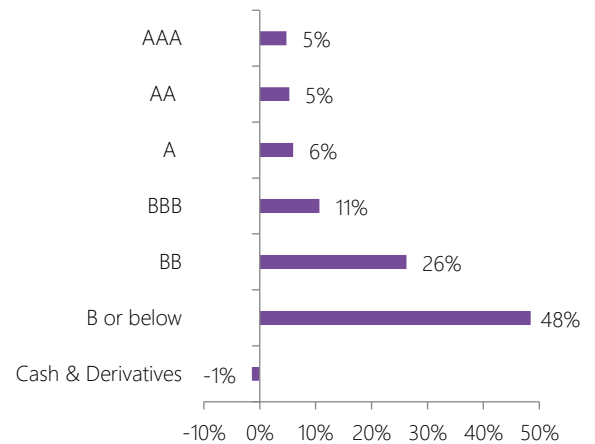
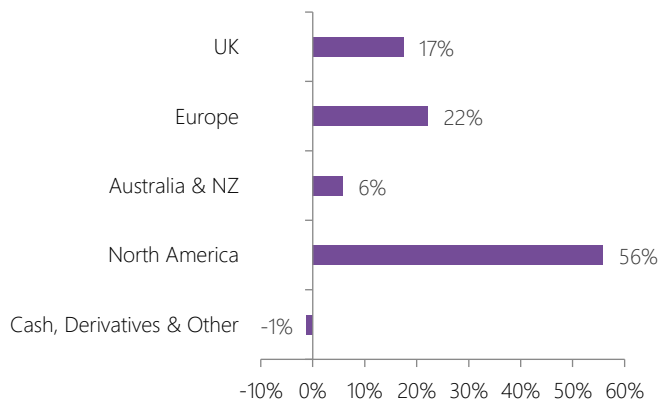
