Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of 0.90% for the month, outperforming the benchmark by 0.89%. The top performing contributors to performance included Global Syndicated Loans, Bank Capital Securities and Investment Grade Credit; whilst the bottom performing contributors included Global Hybrids, Residential Mortgage Backed Securities (RMBS) and Asset Backed Securities (ABS).

Portfolio Asset Allocation

During the month, exposures to Capital Securities, Cash and Equity increased, whilst exposures to Residential Mortgage Backed Securities, Global Hybrids and Basis Trades decreased. Current asset allocations are 14.8% in Global High Yield, 4.0% in Global Hybrids, 52.7% in Global Syndicated Loans, 17.6% in Capital Securities, 8.2% in Collateralised Loan Obligations, 0.1% in Investment Grade Corporate Credit, 2.6% in Residential Mortgage Backed Securities, 0.4% in Equity, 2.0% in Asset Backed Securities and -2.4% in Cash, Derivatives & Credit Hedged.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 16.9% in Banking, 8.2% in CLO and 7.3% in Electronics. The Fund's top three company exposures are: 2.2% in Commerzbank AG, 2.0% in Credit Agricole SA and 2.0% in Qantas Airways Ltd.

Leveraged Loan Market

The top performing leveraged loan industries in October were Consumer Durables, Food And Drug and Consumer Non-Durables with returns (sector performance in USD terms) of 2.57%, 0.96% and 0.83% respectively. The worst performing loan industries were Energy, Media/Telecommunications and Forest Prod/Containers with returns of -0.32%, -0.24% and -0.15% respectively.

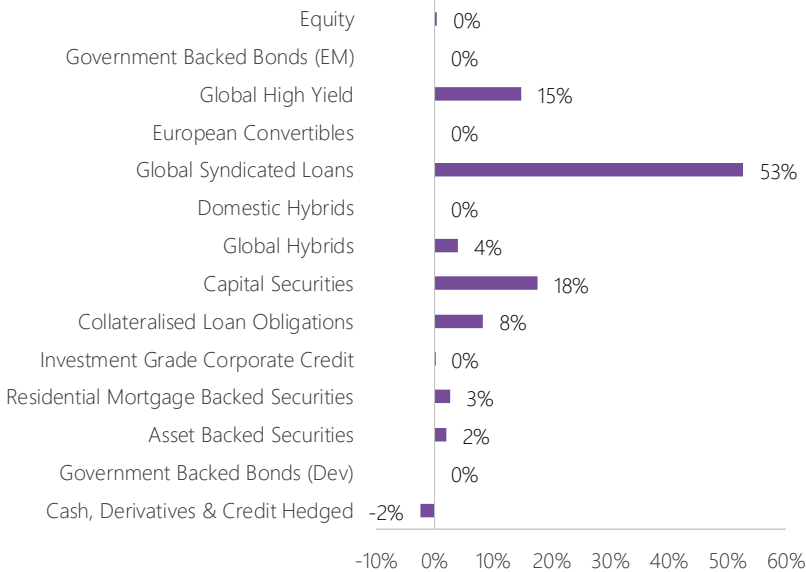
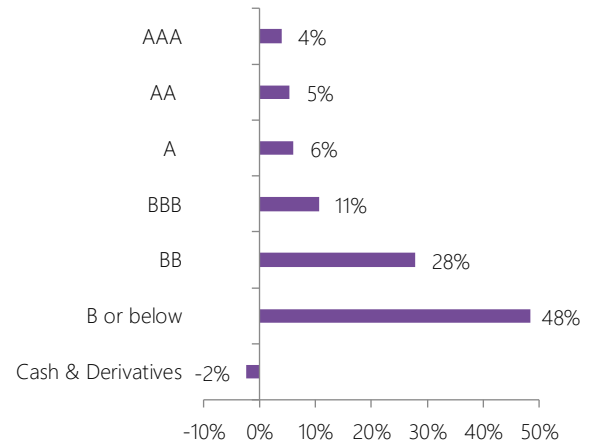
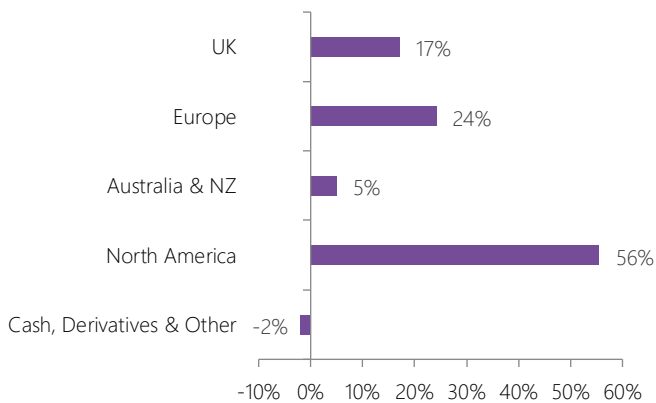
