Fund Aim

To provide diversified exposure to securities across global credit markets, with the flexibility to adapt its credit and cash exposure to suit market conditions across the credit cycle, and deliver consistent levels of income.

Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of 3.30% for the month, outperforming the benchmark by 3.29%. The top performing contributors to performance included Global Syndicated Loans, Bank Capital Securities and Investment Grade Credit; whilst the bottom performing contributors included European Convertibles, Residential Mortgage Backed Securities (RMBS) and Collateralised Loan Obligations (CLO).

Portfolio Asset Allocation

During the month, exposures to Global High Yield, Capital Securities and Investment Grade Corporate Credit increased, whilst exposures to Cash, Basis Trades and Global Syndicated Loans decreased. Current asset allocations are 51.3% in Global Syndicated Loans, 19.4% in Capital Securities, 17.1% in Global High Yield, 7.8% in Collateralised Loan Obligations, 3.7% in Global Hybrids, 2.5% in Residential Mortgage Backed Securities, 1.9% in Asset Backed Securities, 1.1% in Investment Grade Corporate Credit, 0.5% in Equity, 0.1% in Convertibles and -5.4% in Cash, Derivatives & Credit Hedged.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 18.2% in Banking, 7.8% in CLO and 7.0% in Electronics. The Fund's top three company exposures are: 3.0% in Qantas Airways Ltd, 2.4% in Societe Generale and 2.2% in Commerzbank AG.

Leveraged Loan Market

The top performing leveraged loan industries in November were Gaming/Leisure, Aerospace and Energy with returns (sector performance in USD terms) of 4.82%, 4.41% and 3.52% respectively. The worst performing loan industries were Financial, Chemicals and Food And Drug with returns of 1.24%, 1.33% and 1.35% respectively.


