Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of 0.07% in the month of February, underperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index3 (hedged into AUD) by 0.24%. On a before fees basis the fund returned 0.06% for the month, underperforming the benchmark by 0.26%.

High Yield Market

For the month, 14 of the 23 industries had positive returns. The top performing industries in February were Energy, Gaming/Leisure and Diversified Media with returns (sector performance in USD terms) of 2.83%, 0.86% and 0.76% respectively. The worst performing industries were Broadcasting, Telecommunications and Cable/Wireless Video with returns of -1.98%, -0.73% and -0.63% respectively.

The credit yield spread for the Index decreased by 25 bps during the month to 353 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 9.2% in Diversified/Conglomerate Service, 9.0% in Electronics and 7.7% in Healthcare, Education and Childcare. The Fund's top three company exposures are 1.1% in Altice, 0.9% in Radiology Partners and 0.9% in Plastipak. During the month, the Fund increased its exposure to Foundation Building Materials, Maverick Purchaser and Lincoln Financing; with decreased exposures to Sprint Communications, Taseko Mines and United Airlines.




Portfolio Asset Allocation



Regional Breakdown




High Yield Spread to Worst (bps)
