

### Investment Objective

To provide exposure to investment grade global asset backed securities (ABS) and generate stable income with some capital growth.

### Portfolio Returns

The Bentham Asset Backed Securities Fund had a total return (after fees) of 0.34% in the month of March, outperforming the benchmark (Bloomberg AusBond Bank Bill Index) by 0.33%. On a before fees basis the fund returned 0.24% for the month, outperforming the benchmark by 0.24%.

### Portfolio Exposures

The Fund's sector allocations are 30.3% in US Broadly Syndicated Collateralised Loan Obligations (CLO), 21.4% in European CLO, 14.2% in UK Residential Mortgage Backed Securities (RMBS), 10.9% in Cash & Derivatives, 8.2% in Middle Market CLO, 4.9% in Australian RMBS, 3.8% in Aircraft ABS, 2.7% in Credit Card ABS, 2.7% in US Commercial Real Estate (CRE), 0.5% in Auto ABS, 0.3% in European RMBS and 0.1% in Personal Loan ABS.

### Contributors

The top performing contributors to performance included US Broadly Syndicated CLO and Middle Market CLO; whilst the bottom performing contributors included Aircraft ABS and US CRE.

### Outlook

The Fund remains focused on the higher rated tranches of ABS issuance, offering investors a high credit quality, higher yielding, secured alternatives to investment grade corporate and government bonds, with low interest rate risk.

We place a high value on the structural benefits ("terms") typically included in global ABS structures to help preserve the principal of investors in the higher-rated tranches, such as cashflow priority, security, seniority, and reduction in leverage over time.

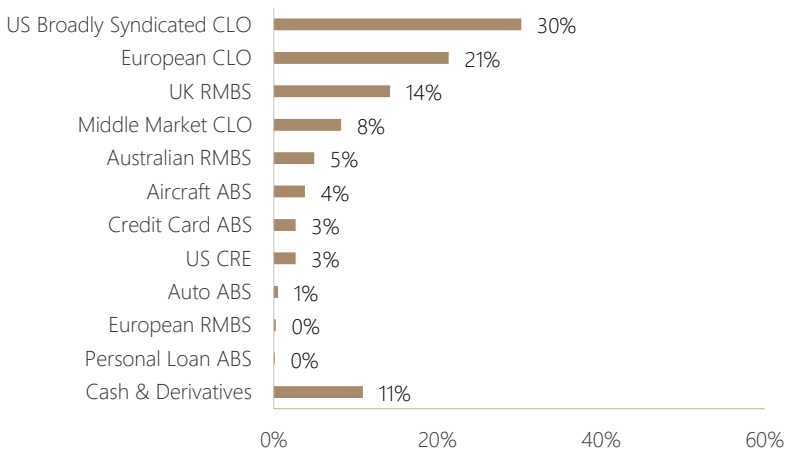
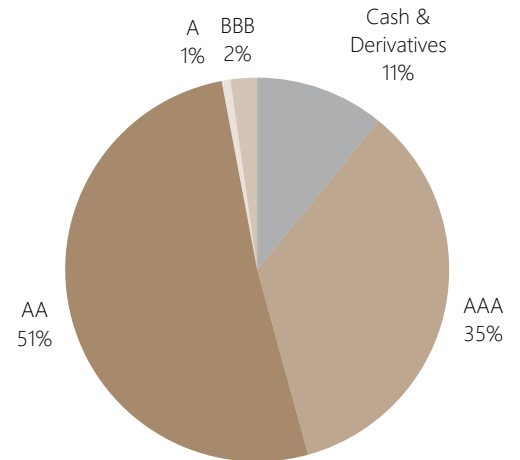
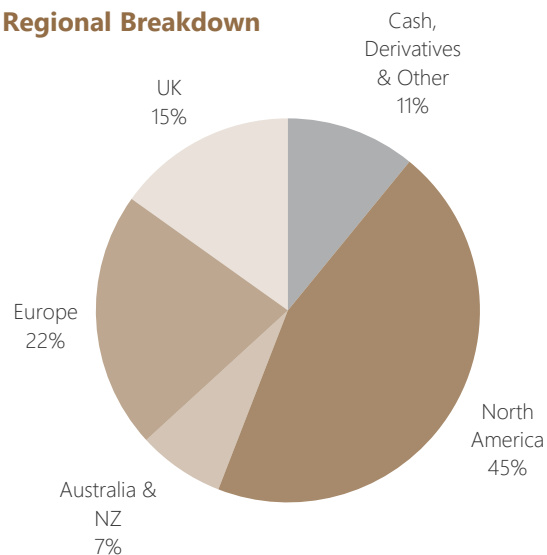
