To provide exposure to investment grade global asset backed securities (ABS) and generate stable income with some capital growth.

### **Portfolio Returns**

Active return (after fees)2

The Bentham Asset Backed Securities Fund had a total return (after fees) of 0.18% in the month of November, outperforming the benchmark (Bloomberg AusBond Bank Bill Index) by 0.17%. On a before fees basis the fund returned 0.21% for the month, outperforming the benchmark by 0.20%.

### **Portfolio Exposures**

The Fund's sector allocations are 28.6% in US Broadly Syndicated Collateralised Loan Obligations (CLO), 23.5% in European CLO, 13.2% in UK Residential Mortgage Backed Securities (RMBS), 10.1% in Middle Market CLO, 6.4% in Australian RMBS, 6.1% in Cash & Derivatives, 4.8% in Aircraft ABS, 3.9% in Credit Card ABS, 2.7% in US Commercial Real Estate (CRE), 0.3% in Auto ABS, 0.2% in European RMBS and 0.1% in Personal Loan ABS.

### **Contributors**

The top performing contributors to performance included European CLO and US Broadly Syndicated CLO; whilst the bottom performing contributors included Australian RMBS and US CRE.

### Outlook

The Fund remains focused on the higher rated tranches of ABS issuance, offering investors a high credit quality, higher yielding, secured alternatives to investment grade corporate and government bonds, with low interest rate risk.

We place a high value on the structural benefits ("terms") typically included in global ABS structures to help preserve the principal of investors in the higher-rated tranches, such as cashflow priority, security, seniority, and reduction in leverage over time.






