Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of -0.69% for the month, underperforming the benchmark by 0.70%. The top performing contributors to performance included Global Syndicated Loans, Investment Grade Credit and Collateralised Loan Obligations (CLO); whilst the bottom performing contributors included Capital Securities, Global Hybrids and Convertibles.

Portfolio Asset Allocation

During the month, exposures to Cash, Global Syndicated Loans and Global High Yield increased, whilst exposures to Government Backed Bonds (Emerging Market), Equity and Convertibles decreased. Current asset allocations are 64.6% in Global Syndicated Loans, 12.9% in Global High Yield, 6.2% in Capital Securities, 6.0% in Investment Grade Corporate Credit, 5.1% in Collateralised Loan Obligations, 2.8% in Global Hybrids, 2.5% in Asset Backed Securities, 0.6% in Equity, 0.5% in Residential Mortgage Backed Securities, 0.1% in Convertibles, -4.2% in Government Backed Bonds (EM) and 2.8% in Cash, Derivatives & Credit Hedges.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 12.5% in Aerospace and Defense, 10.5% in Electronics and 9.8% in Banking. The Fund's top three company exposures are: 3.1% in Qantas Airways Ltd, 2.8% in Commerzbank AG and 2.1% in Heathrow Funding Ltd.

Leveraged Loan Market

The top performing leveraged loan industries in November were Metals/Minerals, Energy and Manufacturing with returns (sector performance in USD terms) of 0.16%, 0.15% and 0.07% respectively. The worst performing loan industries were Aerospace, Utility and Consumer Durables with returns of -0.81%, -0.59% and -0.38% respectively.

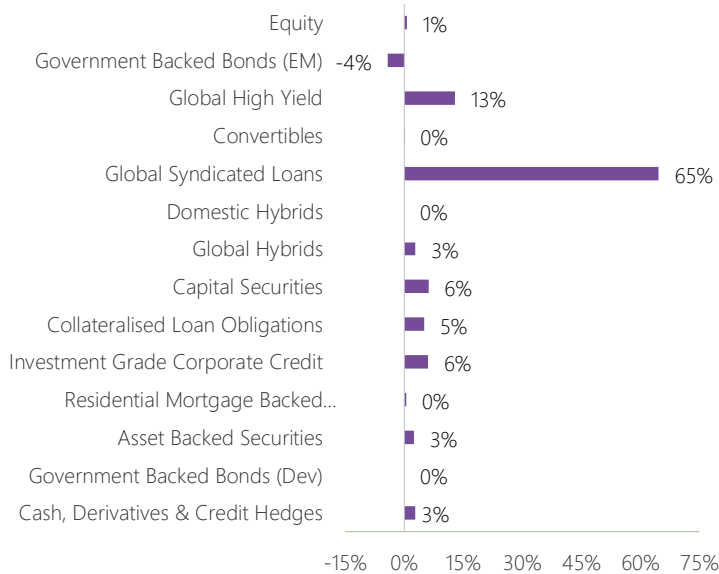
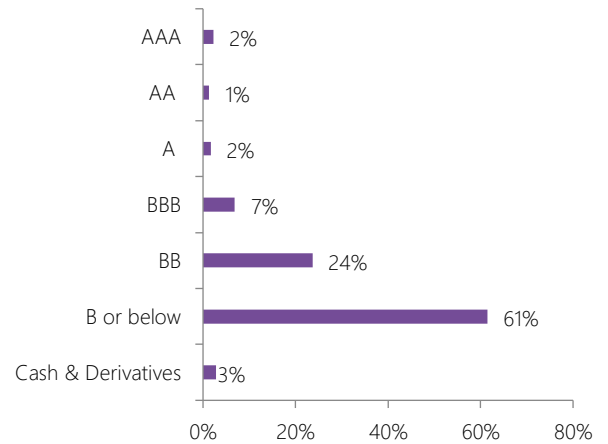
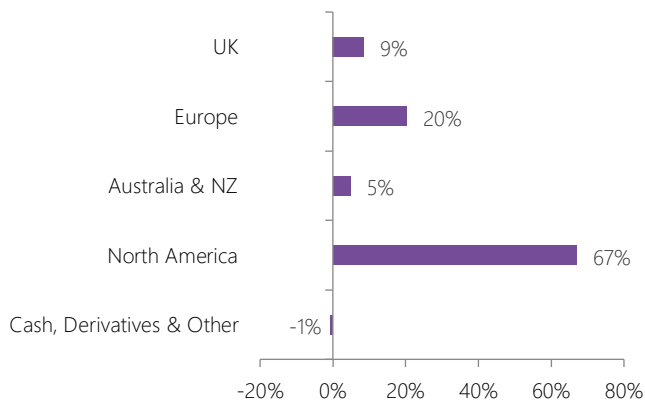
