Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of -0.44% in the month of November, outperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index3 (hedged into AUD) by 0.68%. On a before fees basis the fund returned -0.38% for the month, outperforming the benchmark by 0.73%.

High Yield Market

For the month, none of the 23 industries had positive returns. The top performing industries in November were Transportation, Food And Drug and Housing with returns (sector performance in USD terms) of -0.07%, -0.11% and -0.37% respectively. The worst performing industries were Broadcasting, Energy and Cable/Wireless Video with returns of -2.71%, -1.78% and -1.42% respectively.

The credit yield spread for the Index increased by 51 bps during the month to 361 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 11.8% in Diversified/Conglomerate Service, 9.3% in Healthcare, Education and Childcare and 9.2% in Electronics. The Fund's top three company exposures are 1.2% in Lorca Telecom Bondco SAU, 1.1% in Finastra and 1.0% in Blackstone Mortgage Trust. During the month, the Fund increased its exposure to HUB International, Compass Group Diversified and Kraton Polymers LLC Kraton Polymers Capital; with decreased exposures to Ford Motor, Targa Resources Partners LP Targa Resources Partners Finance C and Pg&e.




Portfolio Asset Allocation
