

**Bentham Global Income Fund NZD**
**December 2021**
**Investment Objective**

The Fund provides exposure to global credit markets and aims to generate income with some potential for capital growth over the medium to long term.

**Portfolio and Market Returns**

The Bentham Global Income Fund NZD had a total return (after fees) of 0.81% in the month of December, outperforming the benchmark (50% Bloomberg AusBond Bank Bill Index (hedged to NZD), 50% Bloomberg AusBond Composite Index (hedged to NZD)) by 0.70%. On a before fees basis the fund returned 0.91% for the month, outperforming the benchmark by 0.79%.

The top contributors to performance included Global Syndicated Loans, Capital Securities and Global High Yield; whilst the bottom performing contributors included Equity Securities, Residential Mortgage Backed Securities (RMBS) and Bond.

After a strong rebound of global economic growth in 2021, we expect this growth to moderate in 2022 as central banks begin withdrawing monetary stimulus given elevated inflation risk. Credit market fundamentals remain sound on average with brokers and credit rating agencies forecasting default rates to remain well below historical averages. Companies are, however, likely to be facing short-term supply chain issues, tight labour markets and lingering pandemic interruptions.

In Bentham's view, credit markets are likely to provide favourable risk adjusted returns over the next 12 months (particularly floating rate credit) despite the increased risk from higher government bond yields. We believe that credit spreads compensate investors for the risk of a slowdown, despite decreasing over the past year spreads are still close to historical averages. Conversely, the strong performance of reflationary assets such as equities and property that resulted from low rates are likely to come under pressure as monetary policy support is withdrawn.

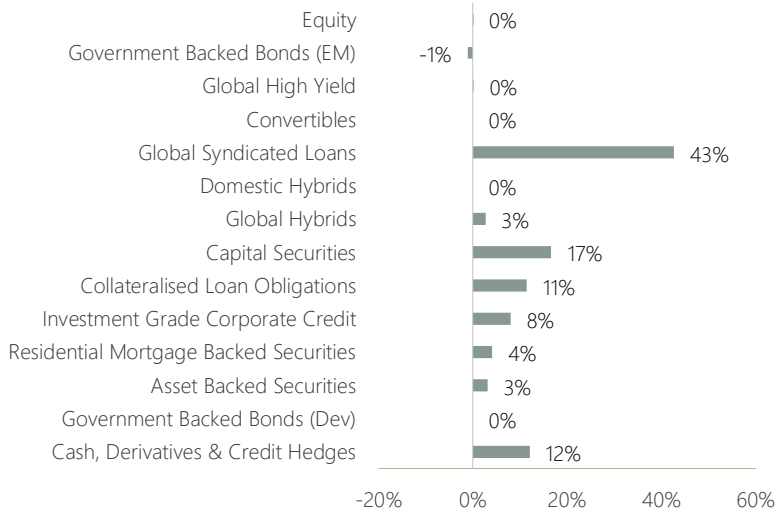
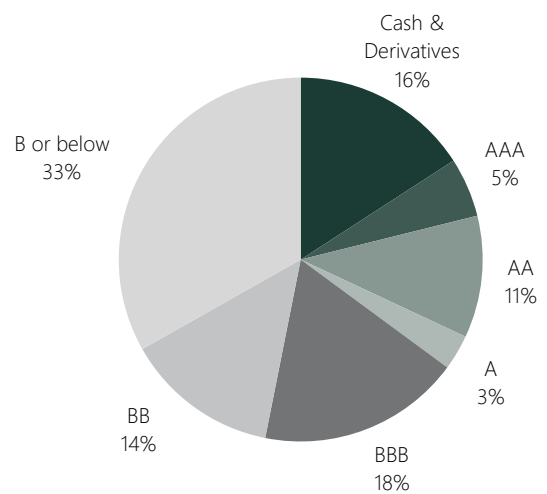
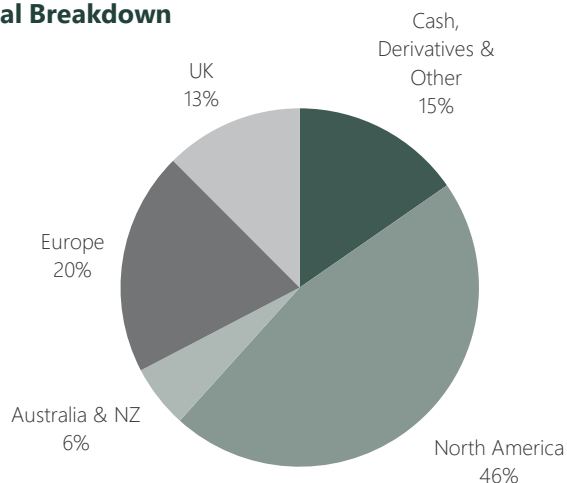
