Investment Objective

The Fund provides exposure to global credit markets and aims to generate income with some potential for capital growth over the medium to long term.

Portfolio and Market Returns

The Bentham Global Income Fund had a total return (after fees) of 0.67% in the month of January, outperforming the benchmark (50% Bloomberg AusBond Bank Bill Index, 50% Bloomberg AusBond Composite Index) by 1.18%. On a before fees basis the fund returned 0.73% for the month, outperforming the benchmark by 1.23%.

January was a challenging start of the year for investors. There were not many investments that offered shelter from the volatility as inflation numbers soared and the US Fed indicated rates would start rising earlier than expected. Equities and government bond markets sold-off in tandem and were positively correlated. While Credit market experienced a mixed month, as fixed rate credit underperformed in the month, the only refuge for positive returns was floating rate ABS and Loans markets.

The top contributors to performance included Global Syndicated Loans, Collateralised Loan Obligations (CLO) and Asset Backed Securities (ABS); whilst the bottom performing contributors included Capital Securities, Investment Grade Credit and Global High Yield.

After a strong rebound of global economic growth in 2021, we expect this growth to moderate in 2022 as central banks begin withdrawing monetary stimulus given elevated inflation risk. Credit market fundamentals remain sound on average with brokers and credit rating agencies forecasting default rates to remain well below historical averages. Companies are, however, likely to be facing short-term supply chain issues, tight labour markets and lingering pandemic interruptions. COVID appears to be in retreat and the world is beginning to reopen. Economic fundamentals are already strong with unemployment low, wages increasing, and prices creating the perfect backdrop for coordinated central bank hikes for the rest of the year across developed markets.

In Bentham's view, credit markets are likely to provide favourable risk adjusted returns over the next 12 months (particularly floating rate credit) despite the increased risk from higher government bond yields. We believe that credit spreads compensate investors for the risk of a slowdown. Despite decreasing over the past year, spreads are still close to historical averages. Conversely, the strong performance of reflationary assets such as equities and property that resulted from low rates are likely to come under pressure as monetary policy support is withdrawn.

Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.






Portfolio Asset Allocation




