Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of 1.07% for the month, outperforming the benchmark by 1.07%. The top performing contributors to performance included Global Syndicated Loans, Collateralised Loan Obligations (CLO) and Asset Backed Securities (ABS); whilst the bottom performing contributors included Investment Grade Credit, Capital Securities and Global Hybrids.

Portfolio Asset Allocation

During the month, exposures to Global Syndicated Loans, Global High Yield and Basis Trades increased, whilst exposures to Cash, Government Backed Bonds (Emerging Market) and Collateralised Loan Obligations decreased. Current asset allocations are 63.3% in Global Syndicated Loans, 15.3% in Global High Yield, 7.1% in Capital Securities, 5.9% in Investment Grade Corporate Credit, 4.3% in Collateralised Loan Obligations, 3.0% in Global Hybrids, 2.6% in Asset Backed Securities, 0.7% in Equity, 0.5% in Residential Mortgage Backed Securities, -4.8% in Government Backed Bonds (EM) and 2.1% in Cash, Derivatives & Credit Hedges.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 13.6% in Aerospace and Defense, 11.3% in Banking and 10.8% in Healthcare, Education and Childcare. The Fund's top three company exposures are: 2.9% in Commerzbank AG, 2.9% in Qantas Airways Ltd and 2.3% in Heathrow Funding Ltd.

Leveraged Loan Market

The top performing leveraged loan industries in January were Aerospace, Metals/Minerals and Consumer Durables with returns (sector performance in USD terms) of 0.78%, 0.69% and 0.59% respectively. The worst performing loan industries were Media/Telecommunications, Retail and Healthcare with returns of 0.12%, 0.28% and 0.28% respectively.

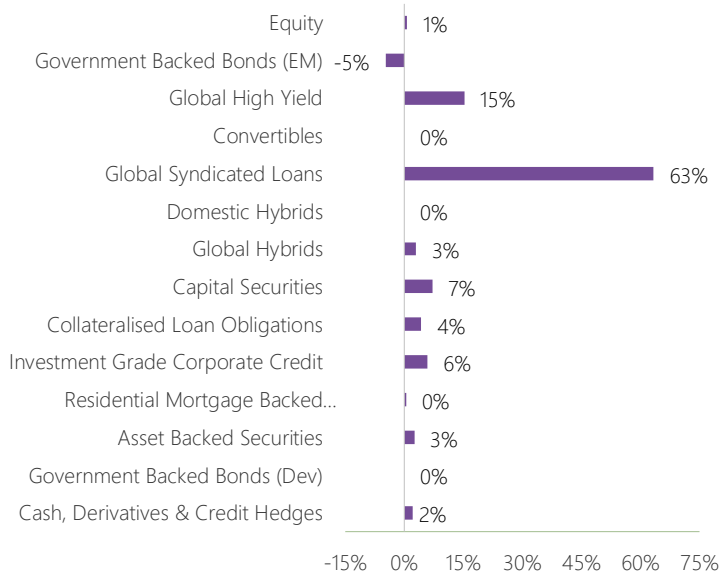
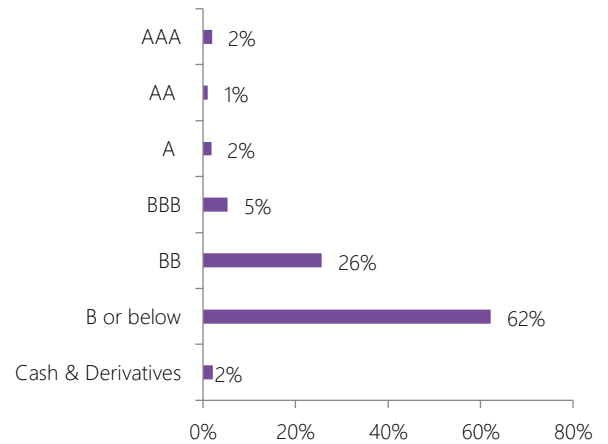
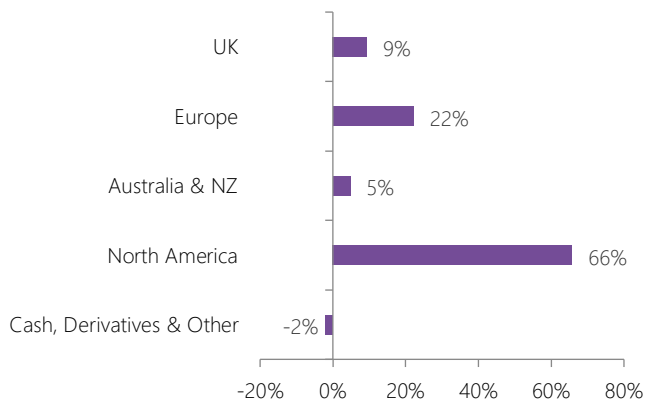
