Investment Objective

The Fund provides exposure to global credit markets and aims to generate income with some potential for capital growth over the medium to long term.

Portfolio and Market Returns

The Bentham Global Income Fund had a total return (after fees) of 0.07% in the month of February, outperforming the benchmark (50% Bloomberg AusBond Bank Bill Index, 50% Bloomberg AusBond Composite Index) by 0.67%. On a before fees basis the fund returned 0.12% for the month, outperforming the benchmark by 0.73%.

The end of February saw the commencement of the war between Russia the Ukraine, with few places for investors to hide in financial markets. Early in the month, Bonds and Equities both sold-off due to inflation fears. At the end of the month volatility spiked due to concerns about the Russia-Ukraine Geopolitical situation sending credit spreads wider.

The top contributors to performance included Collateralised Loan Obligations (CLO), Equity Securities and Residential Mortgage Backed Securities (RMBS); whilst the bottom performing contributors included Capital Securities, Investment Grade Credit and Global Hybrids.

After a strong rebound of global economic growth in 2021, we expect this growth to moderate in 2022 as central banks begin withdrawing monetary stimulus given elevated inflation risk. Credit market fundamentals remain sound on average with brokers and credit rating agencies forecasting default rates to remain well below historical averages. Companies are, however, likely to be facing short-term supply chain issues, tight labour markets and lingering pandemic interruptions.

The Russia-Ukraine situation is a new concern this month though we expect that its impact on markets will primarily be inflationary with the biggest impact to the portfolio felt in Western European Financials where the economy is more susceptible to the stagflationary impulse of sudden energy price shocks. Global Energy and wheat and metal prices have surges but we are wary of a sudden reversal (reflected in the backwardation of the futures curve of those commodity prices).

¹⁰ Bentham intends to achieve the distribution rate for FY2022 with taxable income. If there is a shortfall of taxable income, the distribution may possibly include a capital return. The current distribution rate setting was based on the running yield of the Fund as at 30 June 2021 and assumes the Fund continues to achieve an equivalent yield for FY2022.

Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.






Portfolio Asset Allocation
