To provide diversified exposure to securities across global credit markets, with the flexibility to adapt its credit and cash exposure to suit market conditions across the credit cycle, and deliver consistent levels of income.

Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of 0.87% for the month, outperforming the benchmark by 0.86%. The top performing contributors to performance included Convertibles, Collateralised Loan Obligations (CLO) and Residential Mortgage Backed Securities (RMBS); whilst the bottom performing contributors included Capital Securities, Investment Grade Credit and Global Syndicated Loans.

Portfolio Asset Allocation

During the month, exposures to Government Backed Bonds (Emerging Market), Cash and Convertibles increased, whilst exposures to Basis Trades, Global Syndicated Loans and Global Hybrids decreased. Current asset allocations are 60.8% in Global Syndicated Loans, 15.1% in Global High Yield, 6.9% in Capital Securities, 5.5% in Investment Grade Corporate Credit, 4.0% in Collateralised Loan Obligations, 2.3% in Asset Backed Securities, 1.9% in Global Hybrids, 0.7% in Equity, 0.5% in Residential Mortgage Backed Securities, 0.1% in Convertibles, -1.0% in Government Backed Bonds (EM) and 3.2% in Cash, Derivatives & Credit Hedges.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 12.7% in Aerospace and Defense, 11.0% in Banking and 9.8% in Healthcare, Education and Childcare. The Fund's top three company exposures are: 2.8% in Qantas Airways Ltd, 2.7% in Commerzbank AG and 2.2% in Heathrow Funding Ltd.

Leveraged Loan Market

The top performing leveraged loan industries in February were Metals/Minerals, Energy and Gaming/Leisure with returns (sector performance in USD terms) of 0.29%, -0.12% and -0.13% respectively. The worst performing loan industries were Utility, Retail and Media/Telecommunications with returns of -1.28%, -0.76% and -0.72% respectively.




