### Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of -1.70% for the month, underperforming the benchmark by 1.73%. The top performing contributors to performance included Capital Securities, Residential Mortgage Backed Securities (RMBS) and Convertibles; whilst the bottom performing contributors included Global Syndicated Loans, Investment Grade Credit and Global Hybrids.

### Portfolio Asset Allocation

During the month, exposures to Cash, Basis Trades and Equity increased, whilst exposures to Global Syndicated Loans, Global High Yield and Government Backed Bonds (Emerging Market) decreased. Current asset allocations are 55.5% in Global Syndicated Loans, 8.3% in Global High Yield, 8.1% in Capital Securities, 8.0% in Investment Grade Corporate Credit, 4.0% in Collateralised Loan Obligations, 2.5% in Global Hybrids, 2.2% in Asset Backed Securities, 0.8% in Equity, 0.3% in Residential Mortgage Backed Securities, 0.1% in Convertibles, -2.0% in Government Backed Bonds (EM) and 12.1% in Cash, Derivatives & Credit Hedges.

### Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 11.0% in Aerospace and Defense, 10.0% in Banking and 9.9% in Electronics. The Fund's top three company exposures are: 2.4% in Qantas Airways Ltd, 1.9% in Heathrow Funding Ltd and 1.8% in Commerzbank AG.

### Leveraged Loan Market

The top performing leveraged loan industries in May were Food And Drug, Energy and Chemicals with returns (sector performance in USD terms) of -1.66%, -1.73% and -1.84% respectively. The worst performing loan industries were Consumer Durables, Retail and Healthcare with returns of -4.79%, -3.06% and -3.01% respectively.

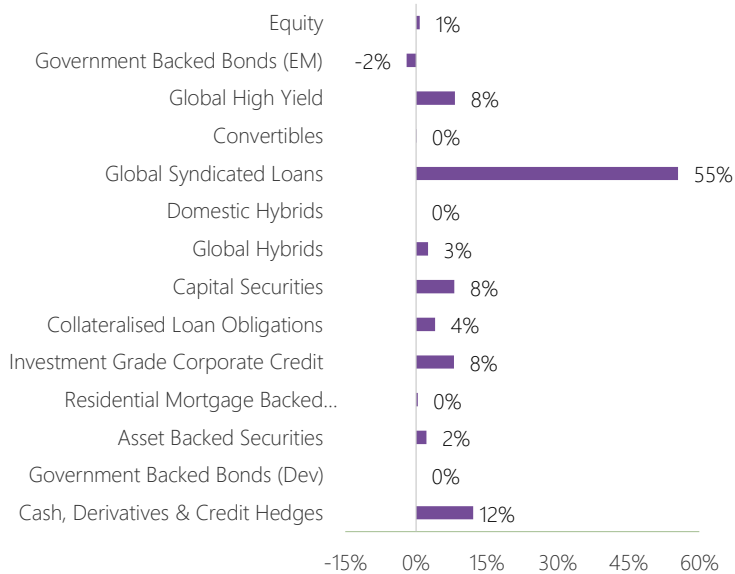
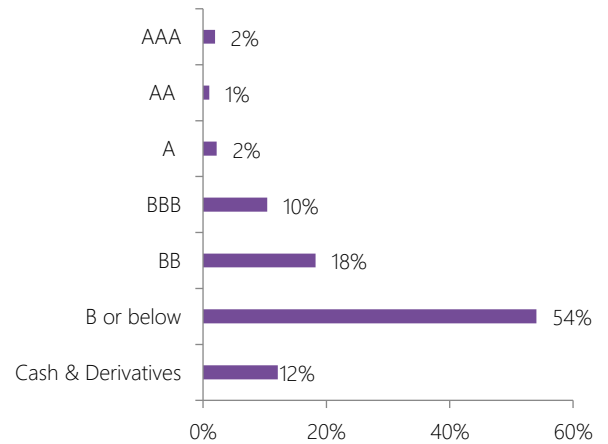
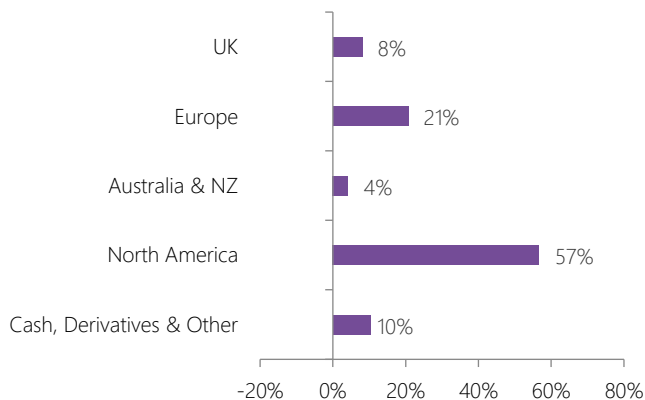
