Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of 2.44% for the month, outperforming the benchmark by 2.31%. The top performing contributors to performance included Global Syndicated Loans, Global Hybrids and Capital Securities; whilst the bottom performing contributors included Asset Backed Securities (ABS), Bond and Collateralised Loan Obligations (CLO).

Portfolio Asset Allocation

During the month, exposures to Investment Grade Corporate Credit, Global High Yield and Government Backed Bonds (Emerging Market) increased, whilst exposures to Global Syndicated Loans, Capital Securities and Cash decreased. Current asset allocations are 49.4% in Global Syndicated Loans, 9.1% in Global High Yield, 7.7% in Investment Grade Corporate Credit, 5.9% in Capital Securities, 3.8% in Collateralised Loan Obligations, 2.1% in Global Hybrids, 1.5% in Asset Backed Securities, 0.7% in Equity, 0.3% in Residential Mortgage Backed Securities, 0.1% in Convertibles, -1.8% in Government Backed Bonds (EM) and 21.1% in Cash, Derivatives & Credit Hedges.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 9.3% in Electronics, 8.6% in Aerospace and Defense and 8.5% in Banking. The Fund's top three company exposures are: 2.0% in Qantas Airways Ltd, 1.6% in Heathrow Funding Ltd and 1.4% in Cooperatieve Rabobank UA.

Leveraged Loan Market

The top performing leveraged loan industries in July were Aerospace, Financial and Food And Drug with returns (sector performance in USD terms) of 2.55%, 2.49% and 2.37% respectively. The worst performing loan industries were Consumer Durables, Metals/Minerals and Utility with returns of 0.04%, 0.69% and 1.35% respectively.

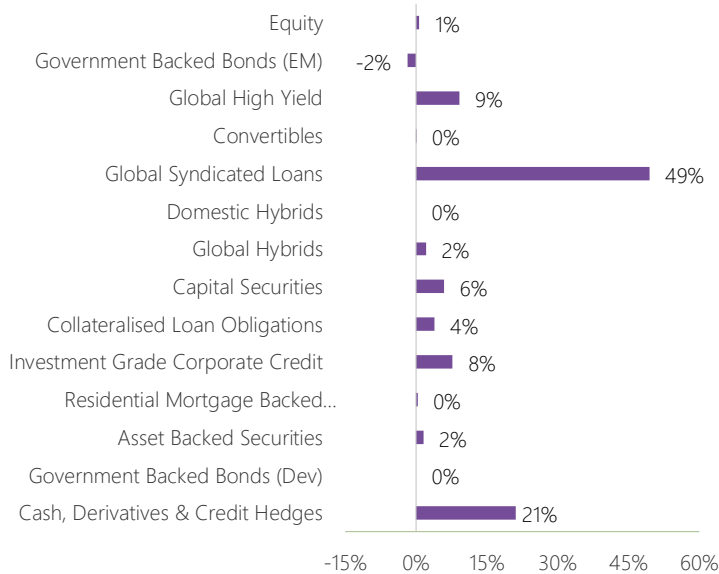
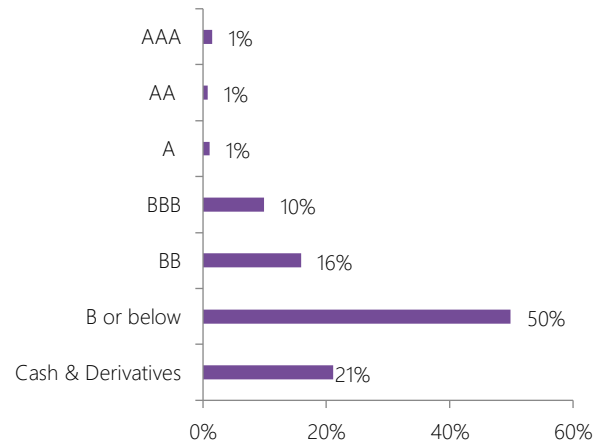
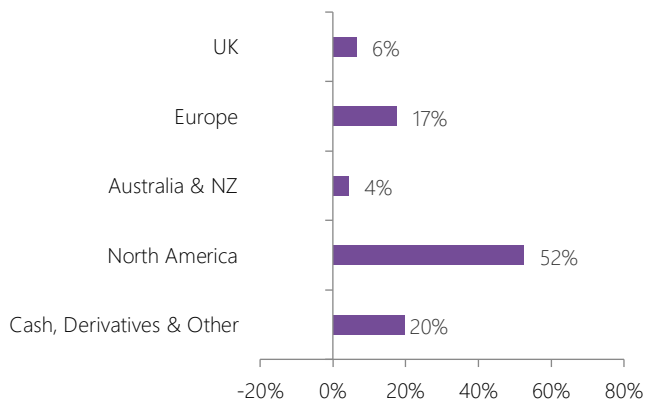
