Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of 0.57% for the month, outperforming the benchmark by 0.41%. The top performing contributors to performance included Global Syndicated Loans, Collateralised Loan Obligations (CLO) and Bond; whilst the bottom performing contributors included Investment Grade Credit, Capital Securities and Global Hybrids.

Portfolio Asset Allocation

During the month, exposures to Capital Securities, Basis Trades and Collateralised Loan Obligations increased, whilst exposures to Global High Yield, Investment Grade Corporate Credit and Global Syndicated Loans decreased. Current asset allocations are 48.4% in Global Syndicated Loans, 8.7% in Capital Securities, 7.2% in Global High Yield, 5.9% in Investment Grade Corporate Credit, 5.1% in Collateralised Loan Obligations, 2.0% in Global Hybrids, 1.5% in Asset Backed Securities, 0.7% in Equity, 0.3% in Residential Mortgage Backed Securities, 0.1% in Convertibles, -1.9% in Government Backed Bonds (EM) and 21.9% in Cash, Derivatives & Credit Hedges.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 11.4% in Banking, 8.7% in Electronics and 7.3% in Healthcare, Education and Childcare. The Fund's top three company exposures are: 1.5% in Heathrow Funding Ltd, 1.4% in Credit Suisse Group Ag and 1.3% in Cooperatieve Rabobank UA.

Leveraged Loan Market

The top performing leveraged loan industries in August were Retail, Housing and Consumer Non-Durables with returns (sector performance in USD terms) of 2.86%, 2.59% and 2.13% respectively. The worst performing loan industries were Consumer Durables, Financial and Healthcare with returns of 0.97%, 1.09% and 1.19% respectively.

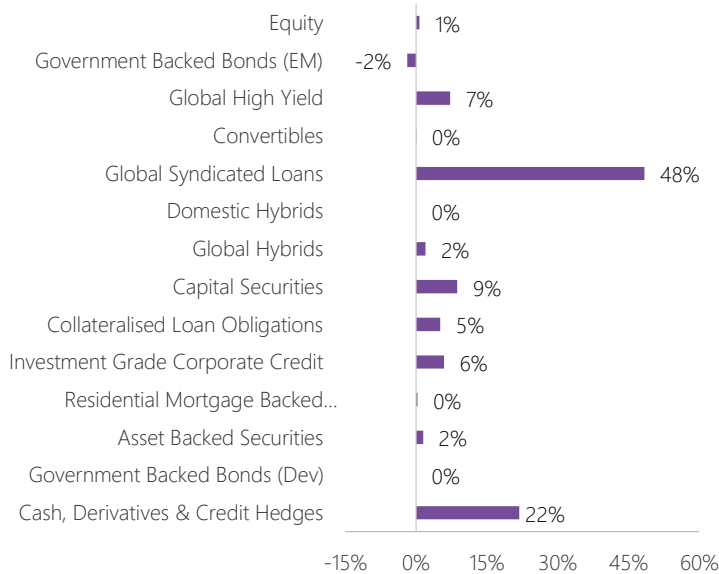
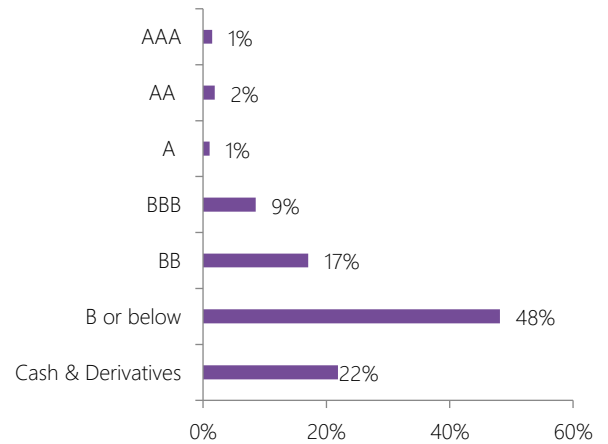
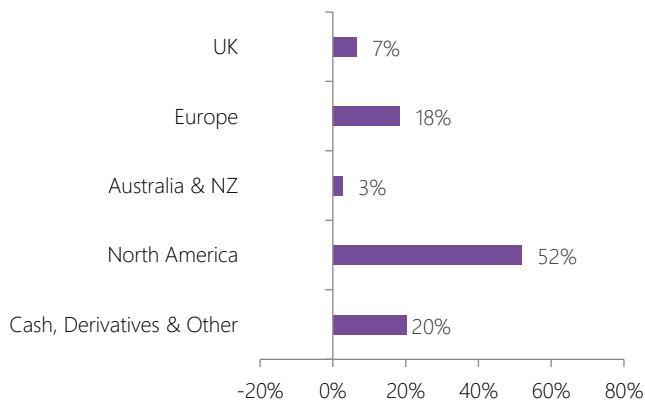
