To provide diversified exposure to securities across global credit markets, with the flexibility to adapt its credit and cash exposure to suit market conditions across the credit cycle, and deliver consistent levels of income.

Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of -1.25% for the month, underperforming the benchmark by 1.40%. The top performing contributors to performance included Residential Mortgage Backed Securities (RMBS), Convertibles and Collateralised Loan Obligations (CLO); whilst the bottom performing contributors included Global Syndicated Loans, Capital Securities and Investment Grade Credit.

Portfolio Asset Allocation

During the month, exposures to Basis Trades, Cash and Investment Grade Corporate Credit increased, whilst exposures to Capital Securities, Global High Yield and Global Syndicated Loans decreased. Current asset allocations are 46.4% in Global Syndicated Loans, 6.2% in Investment Grade Corporate Credit, 5.3% in Collateralised Loan Obligations, 4.7% in Capital Securities, 4.1% in Global High Yield, 2.0% in Global Hybrids, 1.5% in Asset Backed Securities, 0.8% in Equity, 0.3% in Residential Mortgage Backed Securities, 0.1% in Convertibles, -3.0% in Government Backed Bonds (EM) and 31.6% in Cash, Derivatives & Credit Hedges.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 12.3% in Banking, 8.6% in Electronics and 7.1% in Healthcare, Education and Childcare. The Fund's top three company exposures are: 2.7% in Credit Suisse Group Ag, 1.3% in Heathrow Funding Ltd and 1.3% in Cooperatieve Rabobank UA.

Leveraged Loan Market

The top performing leveraged loan industries in September were Food and Drug, Utility and Energy with returns (sector performance in USD terms) of -0.23%, -0.52% and -0.60% respectively. The worst performing loan industries were Metals/Minerals, Gaming/Leisure and Chemicals with returns of -5.06%, -3.03% and -2.98% respectively.

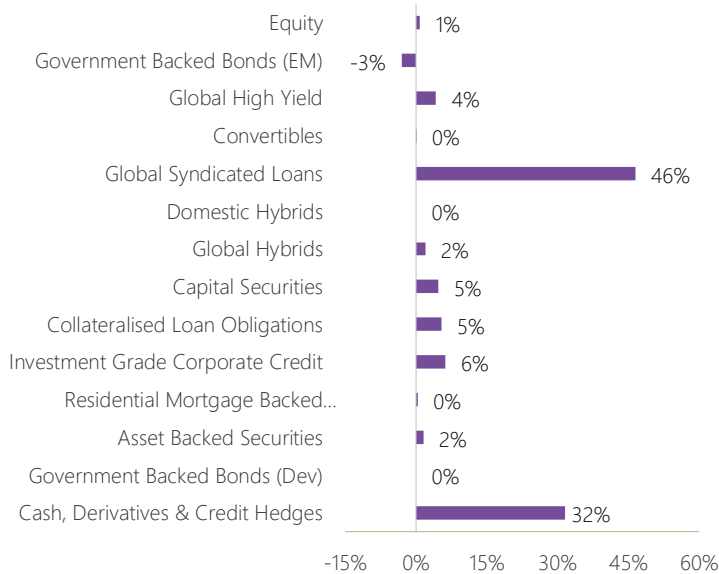
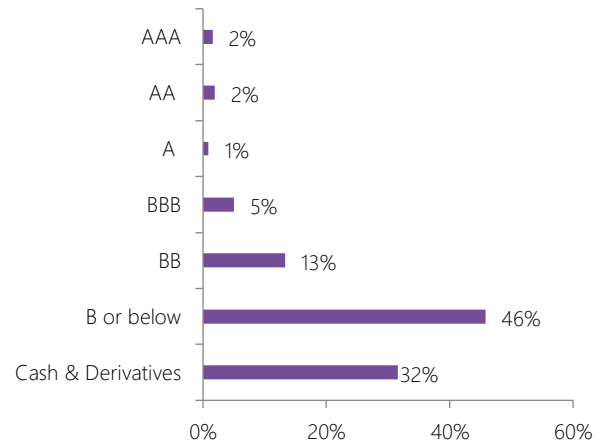
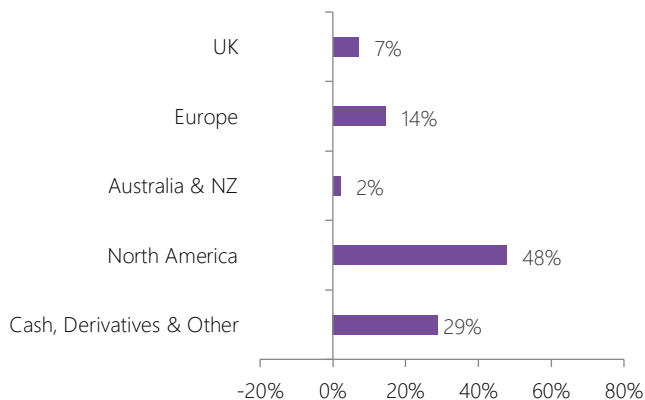
